Pursuant to Condition No. 8 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified by the Certificate Holder should AT&T decide not to install their telecommunications equipment on the tower.



Please accept this letter from InSite Towers Development, LLC as holder of the Certificate of Environmental Compatibility and Public Need issued by the Siting Council in Docket 452 ("Certificate"). Condition 7 of the Decision and Order dated March 5, 2015 required the approved facility to be fully constructed and providing wireless services within eighteen (18) months from the date of the mailing of the Council's Findings of Fact, Opinion, and Decision and Order. On June 23, 2016, Council granted an eighteen (18) month extension of time to March 5, 2018 to complete construction of the facility.

Although the tower is constructed and the Salisbury Ambulance has recently submitted an application to install a public safety antenna on the tower in first quarter of 2018, AT&T continues at this time to make arrangements for the installation of their facility to the tower site. In keeping with Condition 8 of the Decision and Order, we respectfully request a second eighteen (18) month extension, which would extend out to September 5, 2019.
