Directions to SITE at 199 Brickyard Road, Farmington.

From Interstate 84 (from Waterbury, Hartford)

Follow Interstate 84 to Exit 39 for Route 4 west.

Follow Route 4 west through Farmington village (numerous traffic lights) and passing a golf course on right.

After golf course, proceed approximately 0.8 mile to traffic light at Brickyard Road (Wood N Tap restaurant on corner).

Turn right onto Brickyard Road and proceed 1 mile to site property on right at 199 Brickyard Road, (with a low brick building).

From Route 9 (New Britain)

Follow Route 9 North to Interstate 84 westbound

Once on I-84, follow directions above.

Directions to TOWN HALL at 1 Monteith Drive Farmington

From Site

Turn left out of site property onto Brickyard Road, returning to Route 4.

At Route 4 traffic light, turn right.

Proceed one mile on Route 4 west to traffic light at Monteith Drive.

Turn right onto Monteith Drive and take first right into driveway for Town Hall.

From Interstate 84

Follow Interstate 84 to Exit 39 for Route 4 west.

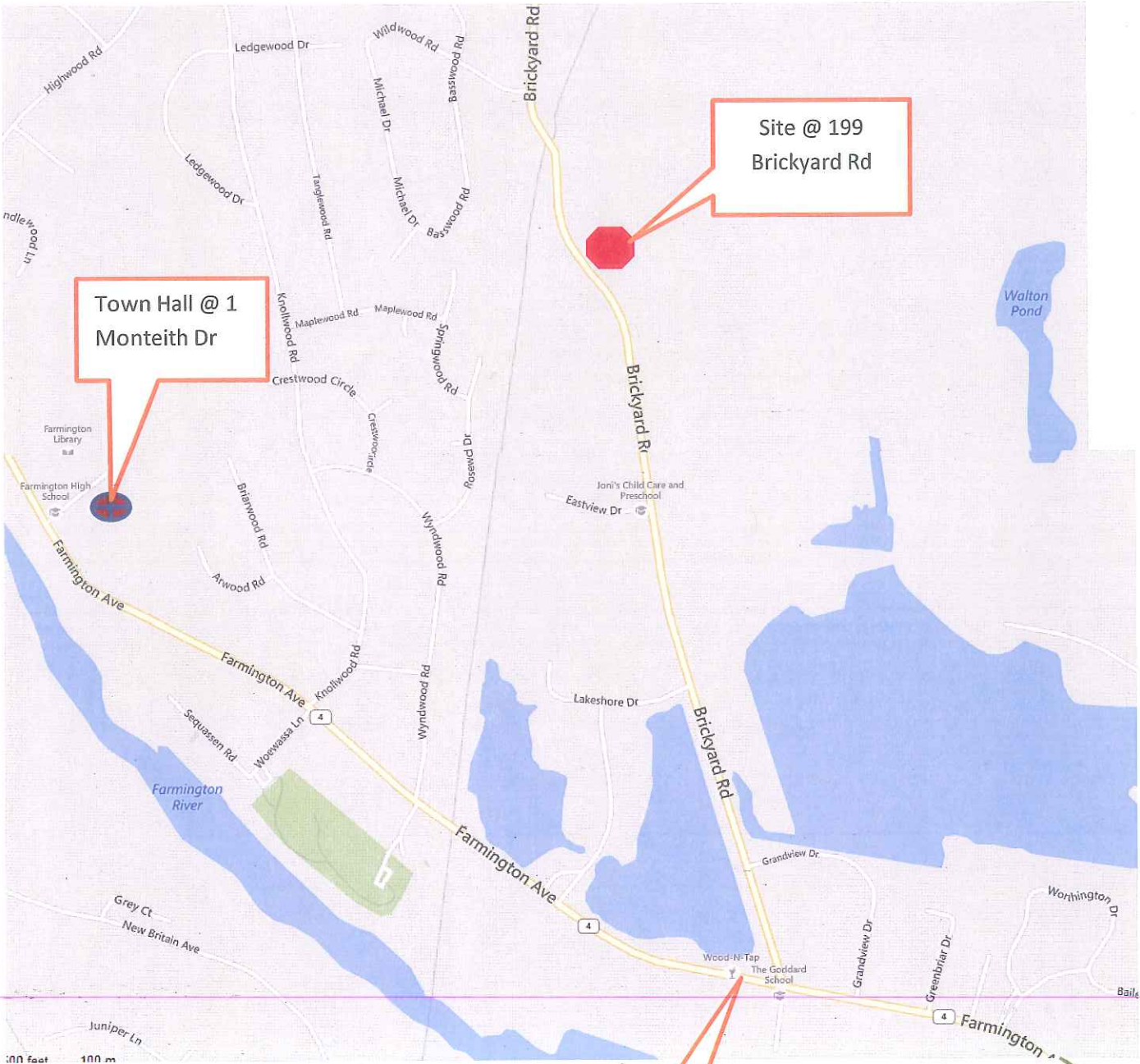
Follow Route 4 west 3.9 miles to Monteith Drive (traffic light).

Turn right onto Monteith Drive and take first right into driveway for Town Hall.

To Restaurant – Wood N Tap – corner of Brickyard Yard and Route 4

From Monteith Drive, turn left onto Route 4 east.

Travel 1 mile to Wood N Tap on left, limited parking in lot, you may have to park along Brickyard Road.
