

Dear Ms. Bachman:

The Drinking Water Section (DWS) of the Department of Public Health has reviewed the location and basic project information associated with the above noted Docket No. 455. This project is contained within the Southington Water Department's (PWSID #CT1310011) Aquifer Protection Area (APA) for Wells #7 & #8.

The DWS offers the following recommendations to protect this source of public drinking water:

- Servicing of machinery should be completed outside of the Aquifer Protection Area. If this not feasible, servicing within the APA should only be conducted at an appropriate service and repair facility.
- Refueling of vehicles or machinery should take place on an impervious pad with secondary containment designed to contain fuels.
- Fuel and other hazardous materials should not be stored within the APA. Any fuel or hazardous
 materials that must be kept within the APA during working hours should be stored on an
 impervious surface utilizing secondary containment.
- A fuel spill remediation kit should be stored on-site so that any spills may be contained and cleaned quickly.
- A responsible party should be identified for maintenance, inspection, repair, and replacement and incorporation of new controls as may become necessary.
- Southington Water Department personnel should be allowed to periodically inspect this project to ensure that drinking water quality is not being adversely impacted.

This project will result in a permanent structure that will require future maintenance and operation of the proposed tower, all ground equipment including provisions for back-up power and fuel storage and an access road. Therefore, all above referenced recommendations should be considered for the lifetime of the structure.
