## NOTICE

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Section 16-50l-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council ("Siting Council") on or after February 25, 2015 by New Cingular Wireless PCS, LLC ("AT&T" or the "Applicant") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in Monroe, Connecticut.

The proposed Facility will be located at 30 Cobblers Hill Court identified as parcel number 107-8.02 by the Monroe Tax Assessor. The proposed Facility consists of a 155-foot tall self-supporting tower designed as a tree or "monopine" with an additional 7' branch extension to provide a tapered top and a 75' x 75' tower compound at the base of the tower located in the southeastern portion of the parcel. An associated 11' 6" x 20' unmanned equipment shelter would be installed together with a back-up power generator in the compound. The proposed tower and equipment compound will be enclosed by an eight (8) foot tall fence. The compound and tower will be designed to accommodate space for other carriers as well as emergency communications equipment. Vehicular access to the Facility will be provided from the northeastern area of the cul-desac at the end of Cobblers Hill Court over a new 12' wide gravel access drive a distance of approximately 1,634' to the compound.

The location, height and other features of the Facility are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq.

The Facility is being proposed to allow AT&T to provide service in this area of the State. The Application explains the need, purpose and benefits of the Facility and also describes the environmental impacts of the proposed Facility. The Facility will be available for co-location by other wireless carriers.

A balloon, representative of the height of the proposed Facility, will be flown at the proposed site on the first day of the Siting Council public hearing on the Application, which will take place in the Town, or such other date specified by the Siting Council and a time to be determined by the Siting Council, but anticipated to be between the hours of 12pm and 5pm.
