**AFFIDAVIT**

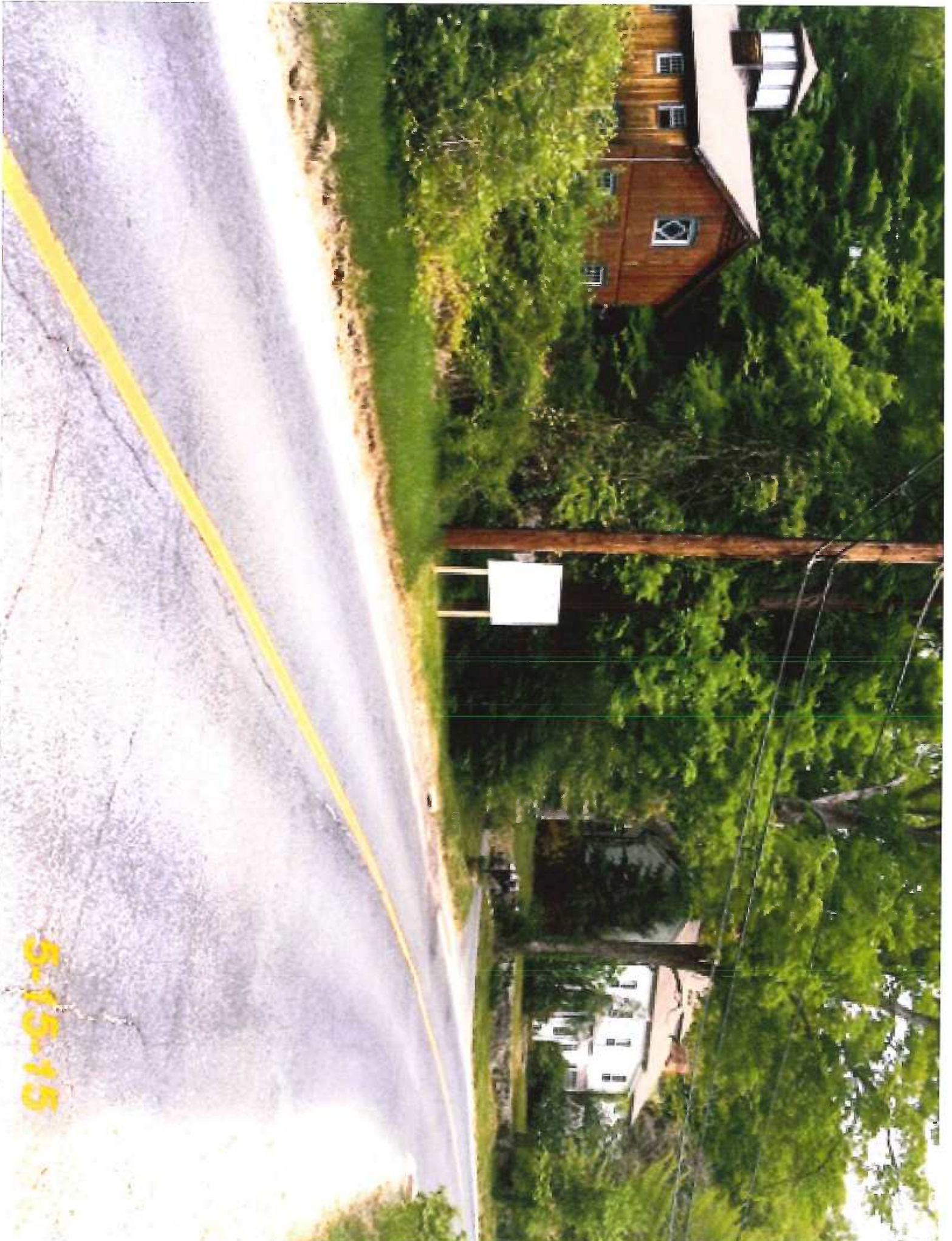
Jon Longobardi of Graphix Edge, being duly sworn, deposes and states that:

5. Photographs of the sign are attached to this affidavit.

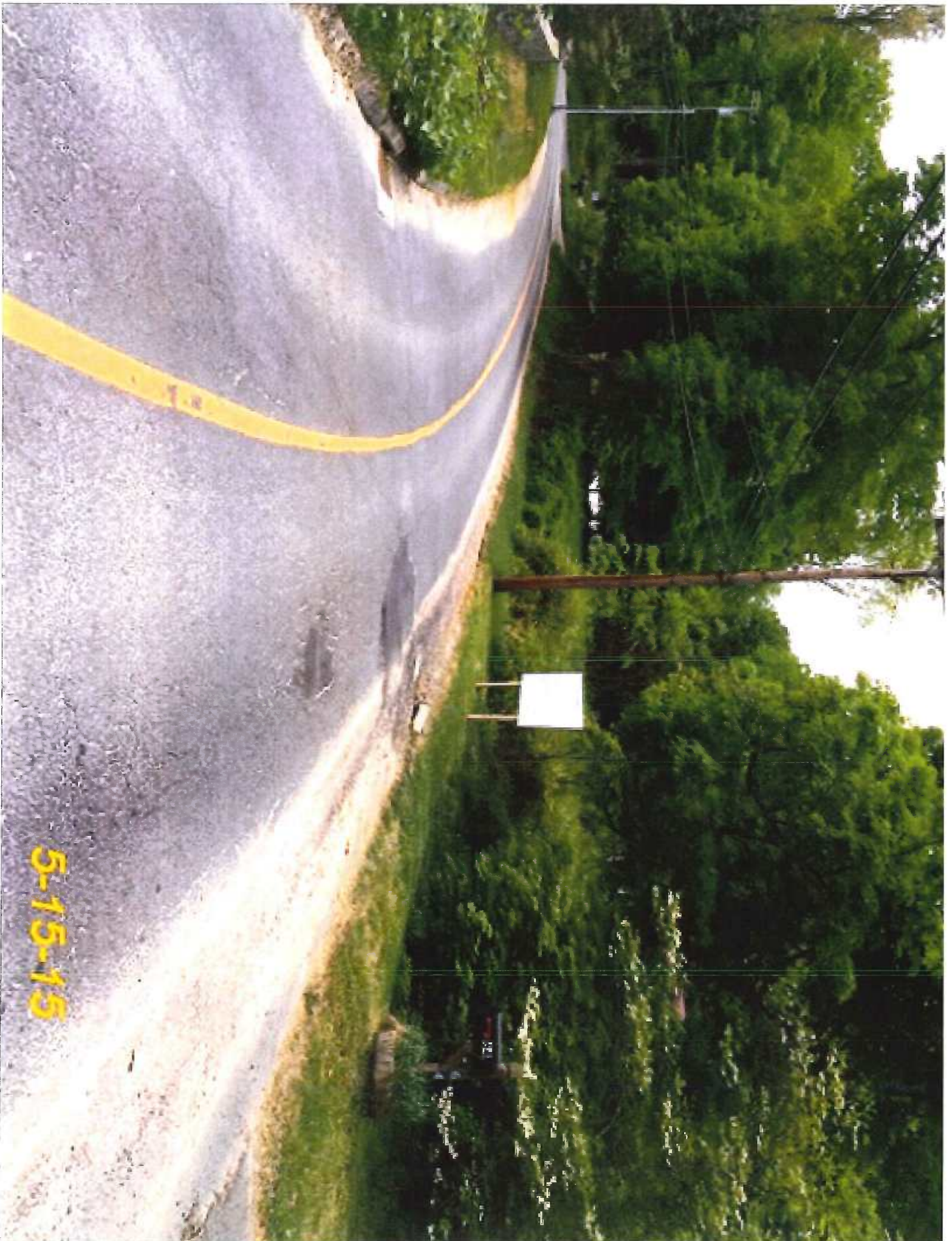
