NOTICE

Notice is hereby given, pursuant to Section 16-50*l*(b) of the Connecticut General Statutes and Section 16-50*l*-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council ("Siting Council") on or after May 8, 2015 by TowerCo 2013, LLC and New Cingular Wireless PCS, LLC (the "Applicants") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications tower facility in Branford, Connecticut.

The tower facility is proposed on property located at 45 Rose Hill Road in Branford, a property currently used as part of a waste refuse company's operations. The proposed facility consists of a 134-foot tall self-supporting monopole tower with required FAA marking/lighting and a 3,600 square foot L-shaped tower compound in the southern portion of the parcel. An associated 11' 5" x 16' unmanned equipment shelter would be installed together with a back-up power generator in the compound. The proposed tower and equipment compound will be enclosed by an eight (8) foot tall fence. The compound and tower will be designed to accommodate space for other carriers. Vehicular access to the facility will be provided from Rose Hill Road over a proposed 12' wide gravel access drive.

The location, height and other features of the Facility are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq. The Facility is being proposed to allow AT&T to provide reliable wireless services in this area of the State. The Application will explain the need, purpose and benefits of the Facility and also describe the environmental effects of the proposed Facility. The Facility will be available for colocation by other wireless carriers.

A balloon, representative of the height of the proposed Facility, will be flown at the proposed site on the first day of the Siting Council public hearing on the Application, or such other date specified by the Siting Council and a time to be determined by the Siting Council, but anticipated to be between the hours of 12pm and 5pm.
