RE: **DOCKET NO. 461A** - Eversource Energy Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 115-kilovolt (kV) bulk substation located at 290 Railroad Avenue, Greenwich, Connecticut, and two 115-kV transmission circuits extending approximately 2.3 miles between the proposed substation and the existing Cos Cob Substation, Greenwich, Connecticut, and related substation improvements.

Dear Ms. Bellion:

Pursuant to Regulations of Connecticut State Agencies §16-50j-62 (b) and in response to your correspondence dated August 28, 2020, the Connecticut Siting Council (Council) staff hereby approves a temporary change to the Development and Management (D&M) Plan to allow for an extension of time until September 12, 2020 for continued use of the 6,800 square foot temporary laydown area at the Bruce Museum. Repaying of damaged asphalt in the laydown area has been delayed and will be completed by September 12, 2020.

This approval applies only to the temporary changes detailed in your correspondence dated August 28, 2020. Any additional changes to the D&M Plan require advance notification and approval in accordance with the Council's approval of the D&M Plan (Volume 2, Part 1) on January 17, 2019. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to Regulations of Connecticut State Agencies Section 16-50j-62.

Please be advised that deviations from this plan are enforceable under the provisions of the Connecticut General Statutes § 16-50u.

Dear Ms. Bachman:

Eversource Energy seeks the approval of Connecticut Siting Council ("Council") staff for an extension until September 12, 2020 for the continued use of 6,800 square feet of the Bruce Museum's paved parking lot as a temporary laydown yard. On July 30, 2020, the Connecticut Siting Council (CSC) staff approved an extension of time, until August 31, 2020, for Eversource's contractor to complete the restoration (repaving) of the 6,800-square foot portion of the Bruce Museum parking lot that was temporarily used to store six large 115-kV transmission cable reels. However, due to a variety of unforeseen events, primarily related to the Tropical Storm Isaias, the storm's aftermath, and a series of more recent major, severe storm events, the repaving of the parking lot will not be completed by August 31, 2020.

Eversource has coordinated with and obtained the endorsement of Bruce Museum and Town of Greenwich representatives regarding this proposed extension of time for the repaving.
