RE: **DOCKET NO. 461A** - Eversource Energy Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 115-kilovolt (kV) bulk substation located at 290 Railroad Avenue, Greenwich, Connecticut, and two 115-kV transmission circuits extending approximately 2.3 miles between the proposed substation and the existing Cos Cob Substation, Greenwich, Connecticut, and related substation improvements.

Dear Ms. Bellion:

Pursuant to Regulations of Connecticut State Agencies §16-50j-62 (b) and in response to your email of May 14, 2020, the Connecticut Siting Council (Council) staff hereby approves a temporary change to the Development and Management (D&M) Plan to allow for one additional work hour this evening (May 14), from 6 PM to 7 PM, in order to complete duct bank concrete work on Indian Harbor Drive that has been delayed by traffic on I-95.

This approval applies only to the temporary additional work hour requested in your email of May 14, 2020. Any additional changes to the D&M Plan require advance notification and approval in accordance with the Council's approval of the D&M Plan on January 17, 2019. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to Regulations of Connecticut State Agencies Section 16-50j-62.

Please be advised that deviations from this plan are enforceable under the provisions of the Connecticut General Statutes § 16-50u.
