RE: **DOCKET NO. 461A** - Eversource Energy Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 115-kilovolt (kV) bulk substation located at 290 Railroad Avenue, Greenwich, Connecticut, and two 115-kV transmission circuits extending approximately 2.3 miles between the proposed substation and the existing Cos Cob Substation, Greenwich, Connecticut, and related substation improvements.

Dear Ms. Bellion:

Pursuant to Regulations of Connecticut State Agencies §16-50j-62 (b) and in response to your email of May 14, 2020, the Connecticut Siting Council (Council) staff hereby approves a temporary change to the Development and Management (D&M) Plan to allow for one additional hour of work (6PM to 7 PM) at the Greenwich Substation from May 18 through May 22, 2020. The additional work hours are necessary to complete substation switchgear installation which was delayed by COVID-19 travel restrictions that prevented the scheduled deployment of a specialized out-of-state contractor.

This approval applies only to the temporary additional work hours requested in your email of May 14, 2020. Any additional changes to the D&M Plan require advance notification and approval in accordance with the Council's approval of the D&M Plan on March 29, 2019. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to Regulations of Connecticut State Agencies Section 16-50j-62.

Please be advised that deviations from this plan are enforceable under the provisions of the Connecticut General Statutes § 16-50u.

Dear Ms. Bachman:

Eversource Energy (Eversource) requests that the Connecticut Siting Council (Council) staff approve an extension of the approved work hours at the Greenwich Substation by one additional one hour. Currently the approved work hours are 7 AM to 6 PM. The requested change in work hours are 7 AM to 7 PM beginning Monday, May 18 through Friday, May 22, 2020) in order to complete work on the distribution switchgear at Greenwich Substation.

Eversource's specialized contractor for this work (AZZ Switchgear) must perform work both inside and outside the switchgear enclosure. This work, which requires a crew of three to four personnel from AZZ's Wisconsin location, was delayed due to COVID-19 travel restrictions. The switchgear work must be completed before other sequential work activities in the substation's construction schedule can commence.

AZZ's work will be entirely within the substation property, which is now enclosed by the brick perimeter wall.

Eversource has consulted with representatives of the Town of Greenwich regarding this extended work hour request.
