2. Regarding the September 13, 2016 Supplemental Filing, what is the date of the aerial photograph behind Tab 3? Are some of the vacant lots shown in the photograph now developed with residential dwellings?
3. For the Alternate Site, please provide a coverage statistics table consistent with Application Tab 1, Radio Frequency Report - Table 2.
4. Application Tab 1, Radio Frequency Report -Table 2 provides coverage statistics for an antenna centerline of 170 feet above ground level. Is this the minimum height requirement for AT&T's proposed installation?
5. In regards to Council interrogatory response 14 (dated December 3, 2015), has the USFWS issued any comment regarding the northern long-eared bat?
