TOWN OF EAST LYME'S RESPONSES TO INTERROGATORIES

The following Interrogatories are directed to the Town of East Lyme by the Intervenor, BHSO Community Conservancy. The requests should be answered by the representative of the Town best suited to provide the response.

1. With regard to the site behind Tab #2 of the Application, Site #9 6 Stone Ranch Road (Military Reservation), please describe what efforts the Town has made to verify if the state police radio tower site can be made available to the Applicants for a tower to provide coverage to the west side of the hill on which the existing to-be-decommissioned cell tower is located.

ANSWER: The First Selectman, Mark Nickerson, spoke to State Representative Edward Jutila and State Senator Paul Formica to inquire if the Stone Ranch Site could be made available for a tower.

2. Please state whether the Town would make site #18 behind Tab 2 of the Application, the existing water tank site available for location of a replacement tower.

ANSWER: The Town has not undertaken to form an opinion of this site because it has been rejected by the Applicant's engineers.

3. With respect to Site #19 behind Application Tab 2, Marion Drive owned by the Town of East Lyme, please state whether this site is subject to a conservation easement, conservation restriction, charitable use restriction, deed restriction, has been dedicated as open space as defined under CGS §7-131 et seq, or has otherwise been encumbered by any Town entity or town meeting as open space upon which a cell tower cannot be constructed.

ANSWER: The Town's research to date reveals that in 1948 the property was conveyed to the Town of East Lyme to satisfy claims the Town had against the Estate and in further consideration of an agreement by the Town to pay all the administrative expenses of the estate.

A substantial portion of the property is in the Town's Aquifer Protection Area as shown on a map attached hereto and identified as **Exhibit A**. Approval to place a tower on the site would be needed from the Town's Zoning Agency.

The property is designated as Open Space in the Town's Plan of Conservation and Development as shown on the map attached hereto as **Exhibit B**. It is also proposed as a Hiking Trail and foot path in the Town's Plan of Conservation and Development.

4. With respect to Site #19 behind Application Tab 2, Marion Drive owned by the Town of East Lyme, if the assessor has designated the site as open space, please state whether that designation is for tax map classification purposes only or whether it encumbers the property in any respect for the purpose of municipal development, including a leased cell tower site.

ANSWER: At the present time, it appears that the Assessor's designation of the site as Open Space is for tax map classification purposes only.

5. With respect to Site #19, Marion Drive, mentioned in the previous interrogatory, please state whether the Town would be willing to provide this site as an alternative

location for a replacement cell tower to the tower proposed in the Application in this Docket.

ANSWER: Approvals would be needed from the Planning Commission, the Acquirer Protection Commission, the Board of Selection and the Zoning Commission and the Town Meeting. At the present time, the Town does not have the authority to "provide the site."

6. If Site #19, Marion Drive, were to be made available by the Town of East Lyme, please state the number of homes within 1000 ft of a tower centrally-located on this site.

ANSWER: The Town's GIS system does not provide the number of "homes" but residences from the perimeter of the property are shown on **Exhibit C** attached hereto.

7. Please state the number of residences within 1000ft of Site #18, the water tank property.

ANSWER: The Town's GIS system does not provide the number of "homes" but residences from the perimeter of the property are shown on **Exhibit D** attached hereto.

8. Please state the number of homes within 1000ft of Site #9 at Stone Ranch.

ANSWER: None.

9. With respect to Site #19 Marion Drive, please state whether this site has been included in any Planning & Zoning decision of the Town of East Lyme as open space as part of a subdivision application, and if so, please provide a map of which portions of the property are so encumbered.

ANSWER: To the best of the Town's knowledge this site has not been included in any decision of the Planning Commission as open space as part of a subdivision application.

10. Please state the number of homes within 1000ft of the proposed tower in this Docket.

ANSWER: The Town's GIS system does not provide the number of "homes" but residences from the perimeter of the property are shown on **Exhibit E** attached hereto.

11. Please state whether the Town believes there are feasible and prudent alternatives to the proposed tower in this Docket and upon what evidence the Town relies in this belief.

ANSWER: The Town gave feasible and prudent alternative in its Limited Appearance Statement filed with the Siting Council on November 19, 2015.

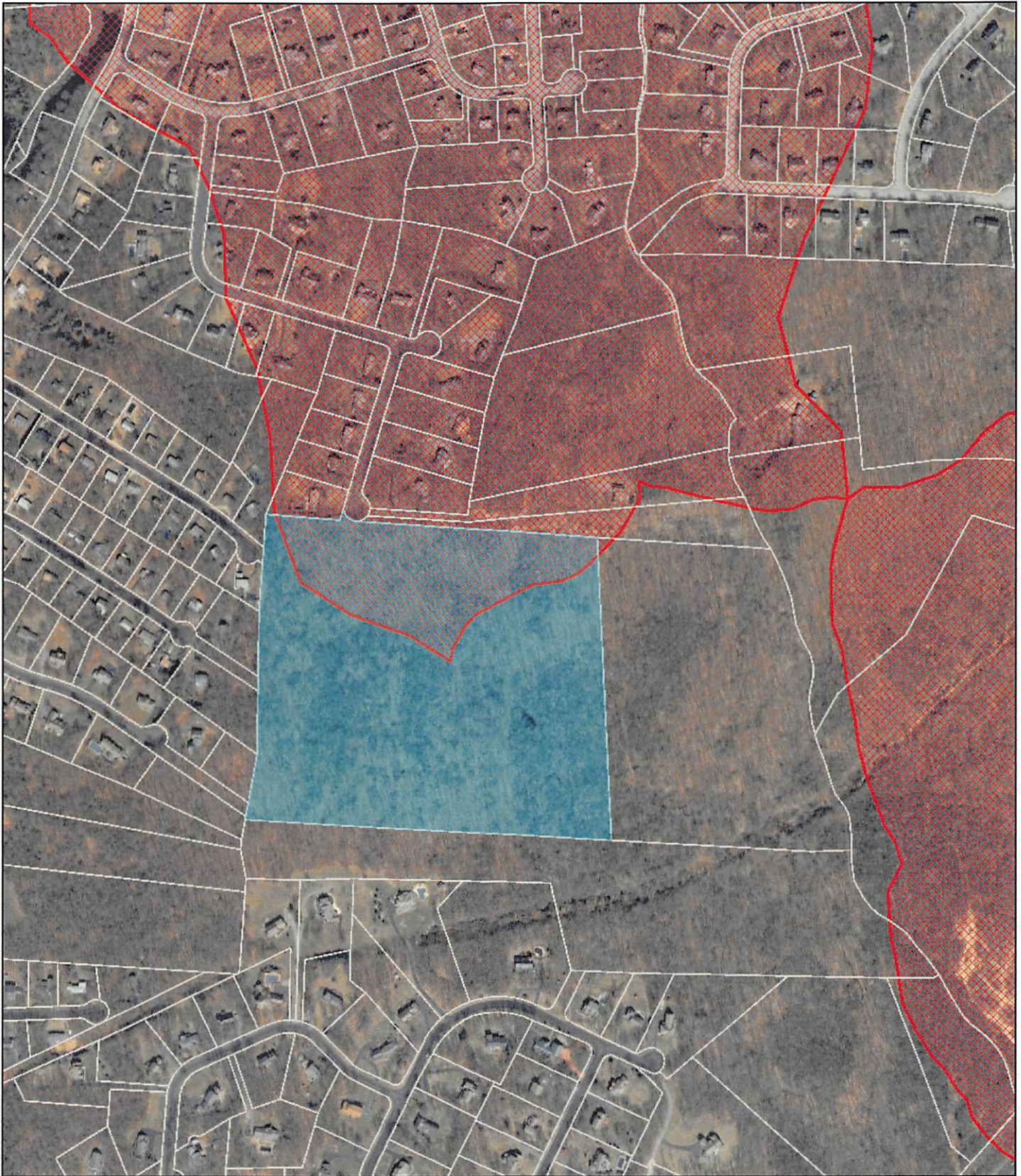

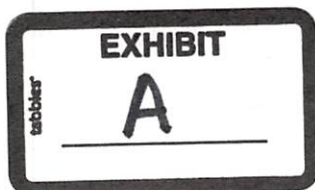

O Marion Drive - Aquifer Protection Area

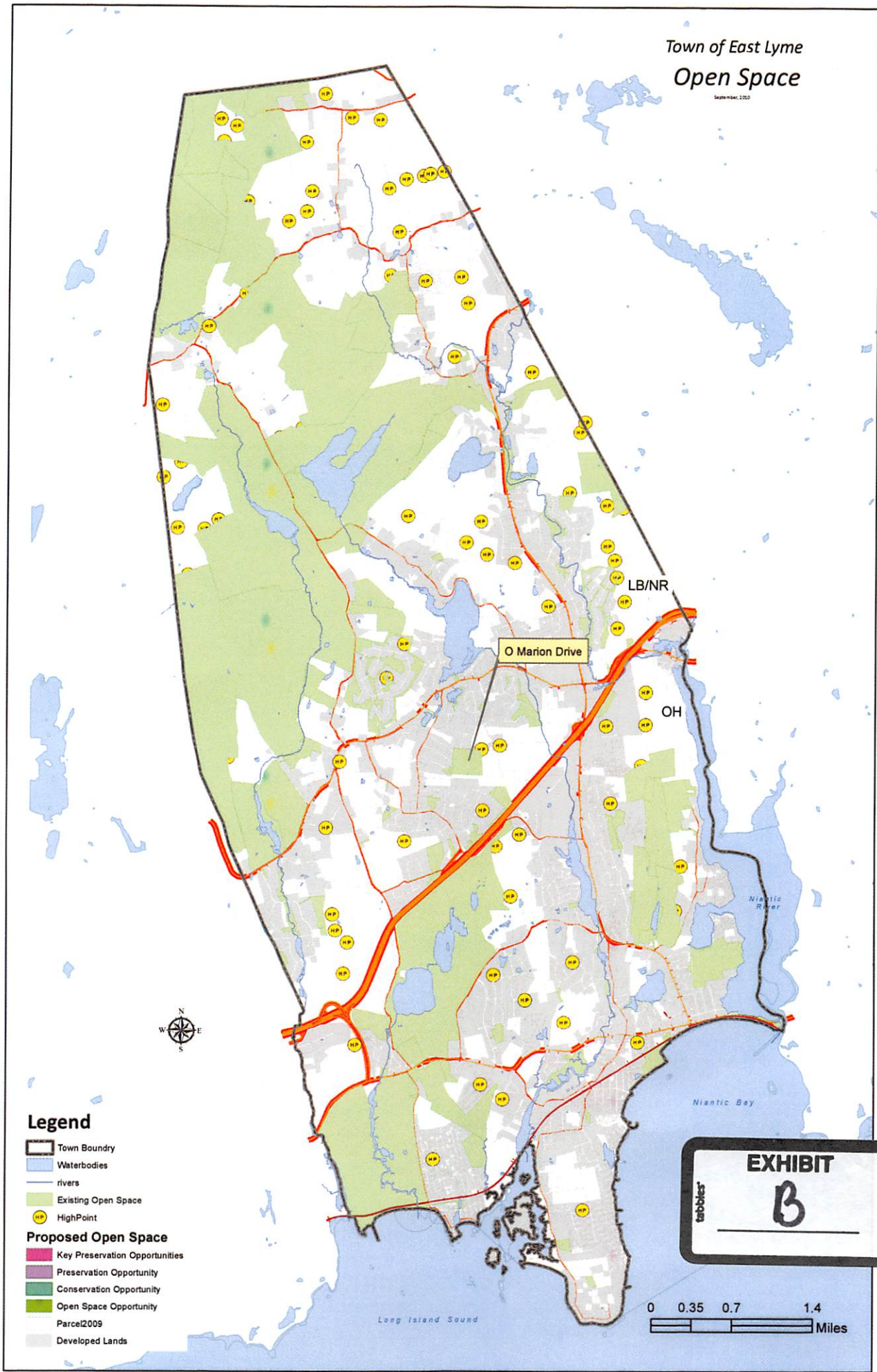

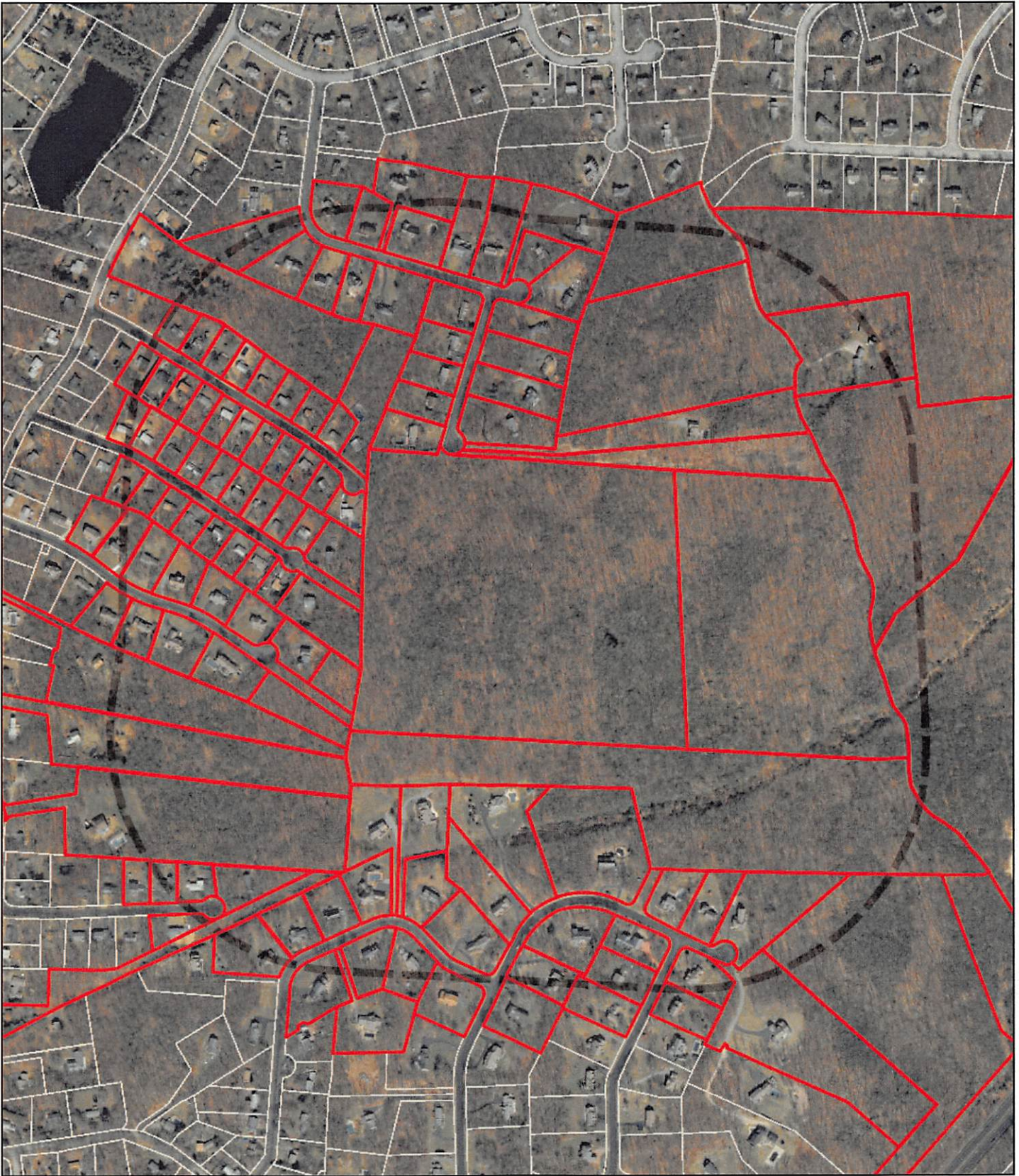
