DOCKET NO. 466 FROST BRIDGE TO CAMPVILLE 115-kV PROJECT MONTHLY CONSTRUCTION PROGRESS REPORT APRIL 2018

1. NEW 115-kV TRANSMISSION LINE AND RELATED TRANSMISSION LINE MODIFICATIONS

During April right-of-way (ROW) inspections were performed to verify the continued integrity of erosion and sedimentation controls during restoration, as well as to update lists of outstanding items to be addressed during restoration activities. Crews mobilized to the ROW during the last week of April and commenced final restoration work.

2. MODIFICATIONS TO FROST BRIDGE AND CAMPVILLE SUBSTATIONS

. No Project work was performed at Frost Bridge Substation.

At Campville Substation, equipment installation and testing work associated with the 1191 and 1921 Line separation continued. All work was performed within the fenced substation or substation control enclosure. The following summarizes the status of substation work as of April 30, 2018.
