TO FIELD REVIEW

From Waterbury Area

Follow I-84 westbound to Exit 9, Route 25 in Newtown.

At end of ramp, turn right, following Route 25 north to Brookfield Center village.

After intersection with Route 133, turn left onto Silvermine Road, (after church).

Follow Silvermine Road over railroad bridge to stop sign with Pocono Road.

Turn left onto Pocono Road and pass Town Hall at 100 Pocono Road.

Turn right into Fire Department at 90 Pocono Road, following paved driveway around firehouse to rear parking area.

From New Haven Area

Follow Interstate 95 southbound to Exit 38, Milford Connector to Route 15.

Follow Route 15 southbound to Exit 49, Route 25 north.

Follow Route 25 north into Brookfield Center village.

After intersection with Route 133, turn left onto Silvermine Road, (after church).

Follow Silvermine Road over railroad bridge to stop sign with Pocono Road.

Turn left onto Pocono Road and pass Town Hall at 100 Pocono Road.

Turn right into Fire Department at 90 Pocono Road, following paved driveway around firehouse to rear parking area.

From Danbury

Follow I-84 eastbound to Exit 7, Route 7/202 north.

Follow Route 7 to Exit 12. At end of ramp, turn left onto Route 202 west (Federal Road)

Turn left at stoplight onto Silvermine Road and go 0.6 mile.

At stop sign, turn right onto Pocono Road and pass Town Hall at 100 Pocono Road.

Turn right into Fire Department at 90 Pocono Road, following paved driveway around firehouse to rear parking area.
