I, Raymond Vergati, being duly sworn, deposes and states that:

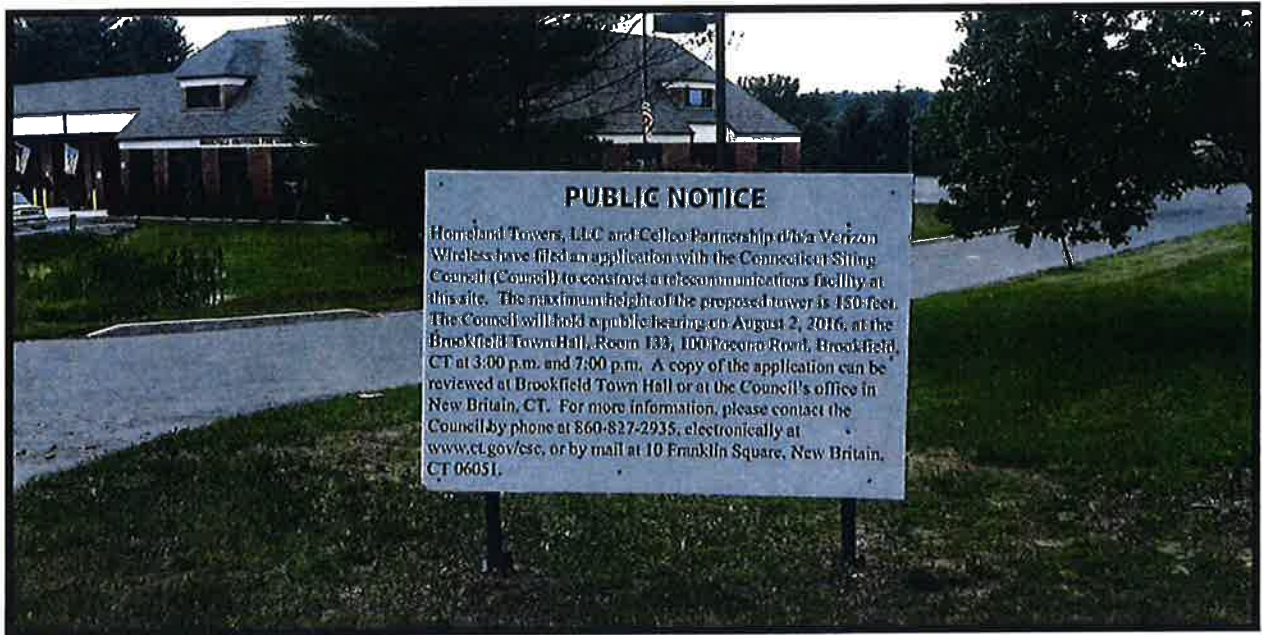
1. I am over eighteen years of age and I understand the obligations of a statement under oath.

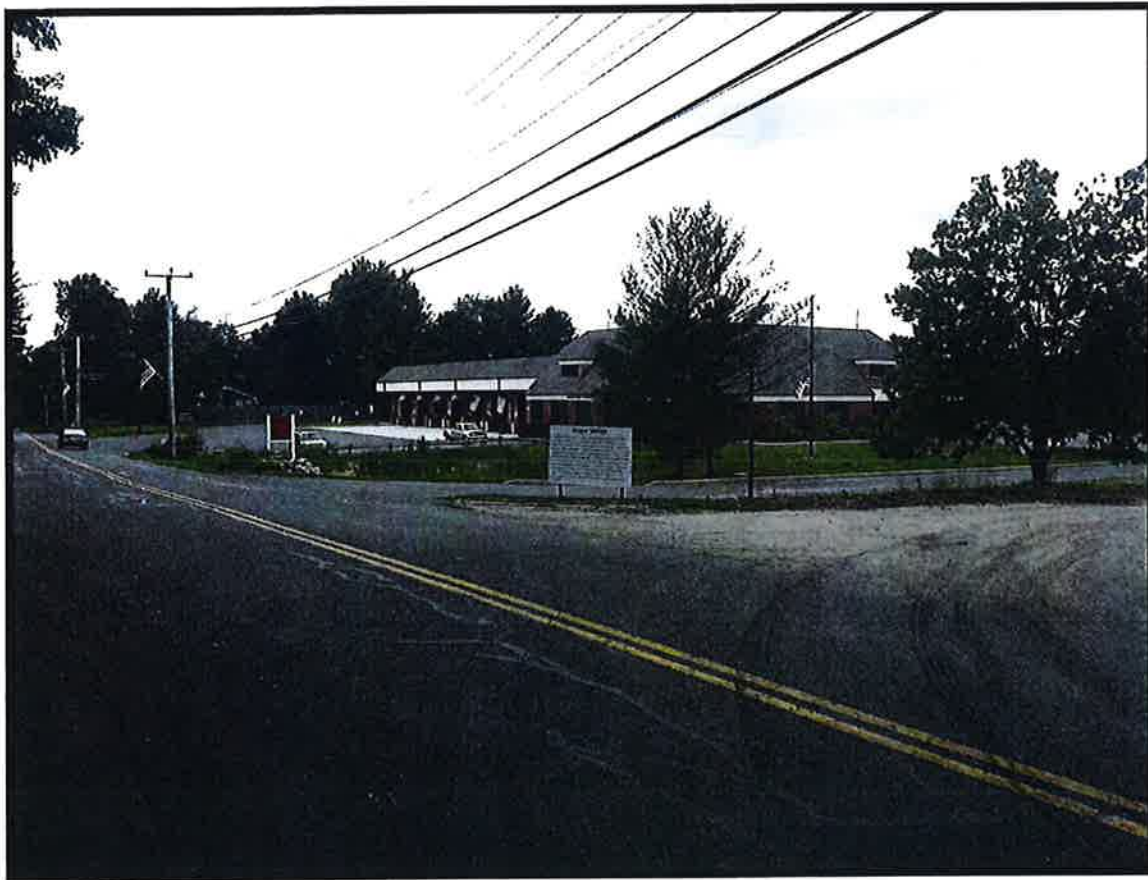
