DOCKET NO. 468 - The Connecticut Light & Power Company d/b/a Eversource Energy application for a Certificate of Environmental Compatibility and Public Need for the Southwest Connecticut Reliability Project that traverses the municipalities of Bethel, Danbury, and Brookfield, which consists of (a) construction, maintenance and operation of a new 115-kV overhead electric transmission line entirely within existing Eversource right-of-way and associated facilities extending approximately 3.4 miles between Eversource's existing Plumtree Substation in the Town of Bethel to its existing Brookfield Junction in the Town of Brookfield; (b) reconfiguration of two existing 115-kV double-circuit electric transmission lines at Eversource's existing Stony Hill Substation in the Town of Brookfield; and (c) related substation modifications.

The Connecticut Siting Council has scheduled a field review for this docket for September 22, 2016 beginning promptly at 1:30 p.m. Council Members should meet at the Bethel Municipal Center, 1 School Street, Bethel at 1:15 p.m. for bus transportation to and along the project route.

A public hearing is scheduled for September 22, 2016 beginning at 3:00 p.m. and continued at 7:00 p.m. in the General Purpose Room at the Bethel Municipal Center, 1 School Street, Bethel.

TO FIELD REVIEW – MEET AT BETHEL MUNICIPAL CENTER, 1 School Street, Bethel @ 1:30 pm for bus transportation to the site.

From Waterbury

Follow I-84 west to Exit 10, Newtown.

Follow Route 6 west into Newtown center.

At flagpole take left onto Route 25 south.

Turn right onto Route 302 west.

Follow Route 302 west into Bethel. (Rt. 302 aka Greenwood Avenue)

At traffic light with Chestnut Avenue (CITGO on corner), turn right and follow Chestnut to the next left – Main Street

Turn left onto Main Street.

At end of Main Street, turn right onto Wooster Street.

Turn left at second access road (red house on corner) to rear lot of Municipal Center.

From New Haven

Follow I-95 west to Merritt Parkway (Rt. 15) in Milford (Exit 38).

Follow Merritt Parkway west to Exit 44-Route 58 north.

Follow Route 58 north through Easton/Redding and into Bethel to junction with Route 302.

Turn left onto Route 302 west.

At traffic light with Chestnut Avenue (CITGO on corner), turn right and follow Chestnut Street to the next left – Main Street

Turn left onto Main Street.

At end of Main Street, turn right onto Wooster Street.

Turn left at second access road (red house on corner) to rear lot of Municipal Center.

From Norwalk

Follow the Merritt Parkway north to Exit 42, for Route 57.

Follow Route 57 north to Route 53 North

Follow Route 53 north to Route 302 east in Bethel

Follow Route 302 east and turn left onto Library Place after railroad tracks.

Turn right onto School Street.

Turn left on Wooster Street.

Turn left at second access road (red house on corner) to rear lot of Municipal Center.
