The Connecticut Siting Council (Council) is in receipt of your recent correspondence concerning Docket No. 471.

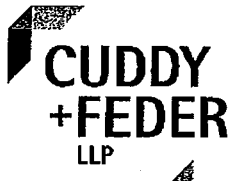
