

**PUBLIC INFORMATION MEETING NOTICE**

Celco Partnership d/b/a Verizon Wireless (“Cellco”) will host a Public Information Meeting on Thursday, April 6, 2017, at 7:00pm at Canterbury Town Hall, 1 Municipal Drive in Canterbury, CT to discuss plans by Cellco to construct a wireless telecommunications facility on property at 46 Cemetery Road in Canterbury.

At the 46 Cemetery Road facility, Cellco proposes to construct a 160-foot monopole tower and a steel platform supporting equipment cabinets and a diesel-fueled back-up generator, within 50’x50’ fenced compound. Cellco antennas would be mounted at the top of the tower.

The telecommunications facility described above is under the exclusive jurisdiction of the Connecticut Siting Council pursuant to the provisions of Section 16-50g et seq. of the General Statutes and are subject to change. Cellco Partnership d/b/a Verizon Wireless (“Cellco”) will host a **Public Information Meeting on Thursday, April 6, 2017, at 7:00 p.m.** in the Canterbury Town Hall, 1 Municipal Drive, Canterbury, Connecticut to discuss a proposal by Cellco to construct a wireless telecommunications facility at 46 Cemetery Road in Canterbury.

The proposed telecommunications facility would be located in the southwest corner of an approximately 41.83-acre parcel owned by Nicholas Holowaty II. At this site, Cellco proposes to construct a 160-foot monopole tower and a 12’ x 26’ steel equipment platform, within a 50’ x 50’ fenced compound and 80’ x 125’ leased area. The equipment platform would support Cellco’s equipment cabinets and a diesel-fueled back-up generator. Cellco’s antennas would be mounted at the top of the tower. The tower and compound would be available to be shared by other wireless carriers and the Town, if a need exists. A set of preliminary project plans for the proposed facility is attached for your review.

The proposed telecommunications facility is under the exclusive jurisdiction of the Connecticut Siting Council (“Council”) pursuant to the provisions of the Public Utilities and Environmental Standards Act, Conn. Gen. Stat. § 16-50g et seq. The Public Information Meeting is intended to provide the general public with information about the proposal prior to the
