Dear Attorney McDermott:

The Connecticut Siting Council (Council) is in receipt of the request for an additional extension of construction time in the above-referenced matter dated September 23, 2024. Pursuant to Condition No. 6 of the Certificate issued on October 12, 2018, the Council hereby grants your request for an extension of time to complete the construction of this facility until December 31, 2025.

Pursuant to Condition Nos. 6 and 7 of the Certificate, any request for an extension to fully construct this electric substation facility shall be filed with the Council not later than 60 days prior to the expiration date of this Certificate and shall be served on all parties and intervenors, as listed in the service list, and the City of Bridgeport.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.
