


I, Jon Longobardi, of Graphix Edge, being duly sworn, deposes and states that:

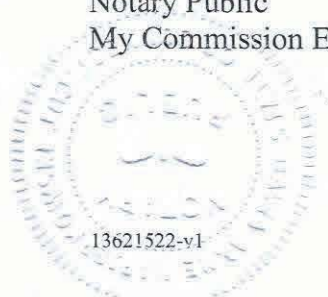

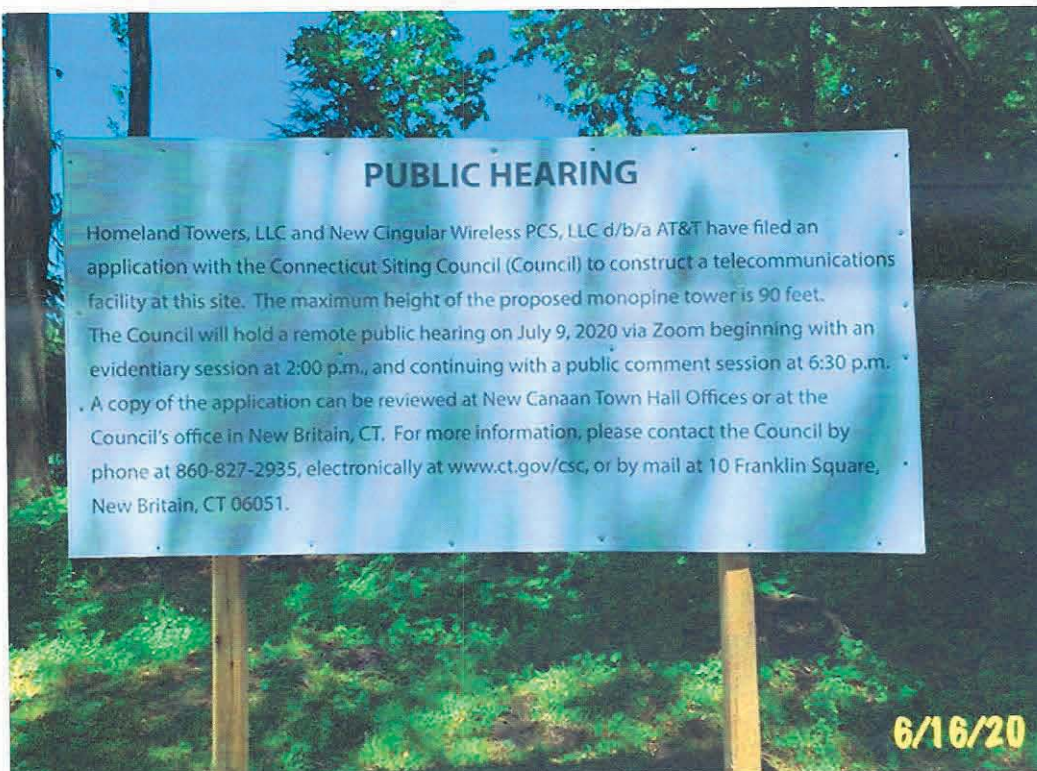
