1. Continuation of Evidentiary Hearing

The Connecticut Siting Council (Council) shall continue the remote evidentiary hearing for the above-referenced proceeding on **Tuesday**, **July 28**, **2020** via Zoom, beginning at **1:00 p.m.**

The hearing shall commence with the continued cross examination of the Applicants by the Soundview Neighbors Group, followed by cross examination of the Applicants by St. Luke's School/St. Luke's Foundation, Inc., and thereafter with the appearance of the parties and intervenors for cross-examination by the Council and the Applicants in the order listed on the July 9, 2020 Hearing Program.

2. Applicants' Late-Filed Exhibits

During the July 9, 2020 evidentiary hearing, the Council requested that the Applicants submit the following information as late-filed exhibits:

- a) Provide a copy of the Site Location Map behind Tab 4 of the Application with the Wiley, Sweeney and Sosnick properties labeled;
- b) Provide a copy of the Site Location Map behind Tab 4 of the Application with the projected tower visibility areas identified for the Wiley, Sweeney and Sosnick properties, as applicable;
- c) Provide the ground elevation of the Wiley residence as compared to the ground elevation of the proposed tower;
- d) Provide a copy of the survey of Town of New Canaan residents regarding wireless towers; and
- e) Provide a copy of the agreement between Homeland Towers LLC and the Town of New Canaan regarding the responsibility for costs related to possible pipe damage in or around the proposed access drive.

The Council requests these late-filed exhibits be submitted to the Council before the close of business on **July 21, 2020.**

Any request for an extension of time to submit the above-referenced late-filed exhibits shall be submitted to the Council in writing pursuant to §16-50j-22a of the Regulations of Connecticut State Agencies.
