RE: **DOCKET NO. 265A** - Dominion Nuclear Connecticut, Inc. Application to Amend and Modify the Certificate of Environmental Compatibility and Public Need for the existing independent spent fuel storage installation at Millstone Power Station, Rope Ferry Road, Waterford, Connecticut pursuant to Connecticut General Statutes § 4-181a(b) for the limited purpose of determining if changed conditions related to the existing independent spent fuel storage installation justify a modification of the Decision and Order.

At the evidentiary hearing for the above referenced matter held on January 29, 2013, the Connecticut Siting Council (Council) ruled on the following matters:

1. **Black Point Beach Club Association Request for Party Status and CEPA Status dated January 23, 2013: Applicant's Objection to Black Point Beach Club Association Request for Party Status and CEPA Status, dated January 25, 2013.** Black Point Beach Club Association requests for Party Status and CEPA status were granted. The Council voted to approve grouping of the Black Point Beach Club Association and the party Nancy Burton and Connecticut Coalition Against Millstone, as both parties exhibited similar interests.
2. **Nancy Burton and Connecticut Coalition Against Millstone Request for administrative notice, received January 29, 2013:** (a) Nancy Burton and Connecticut Coalition Against Millstone's request for administrative notice of Millstone Power Station - NRC Integrated Inspection Report 05000336/2012005 and 05000423/2012005 was granted. (b) Nancy Burton and Connecticut Coalition Against Millstone's request for administrative notice of Amicus Brief in the Matter of *Entergy Nuclear Vermont Yankee, LLC and Entergy Nuclear Operations, Inc. v. Shumlin, et al*, dated June 11, 2012, was denied.
3. **Nancy Burton and Connecticut Coalition Against Millstone Request for Exhibits received January 29, 2013:** Nancy Burton and Connecticut Coalition Against Millstone's request for admission of exhibits, as follows:
  - a) Admission of Preliminary FEMA Map 0491 released 01/17/12, granted as Exhibit 4.
  - b) Admission of aerial photograph of ISFSI, view west, taken on 06/06/06, granted as Exhibit 5A;
  - c) Admission of aerial photograph of ISFSI, view northeast, taken on 06/06/06, granted as Exhibit 5B;
  - d) Admission of photograph of Millstone Seawall representing conditions in 2005, granted as Exhibit 5C.
  - e) Admission of photograph of area near Groton Submarine Base was denied.
