Docket No. 265A - Dominion Nuclear Connecticut, Inc. Application to Amend and Modify the Certificate of Environmental Compatibility and Public Need for the existing independent spent fuel storage installation at Millstone Power Station, Rope Ferry Road, Waterford, Connecticut pursuant to Connecticut General Statutes § 4-181a(b) for the limited purpose of determining if changed conditions related to the existing independent spent fuel storage

installation justify a modification of the Decision and Order.



DIRECTIONS TO FIELD REVIEW

- Take I-95 to Exit 72 (the Rocky Neck Connector)
- At end of exit turn left onto Route 156 East.
- Follow Route 156 East through Niantic, continuing over the Niantic Bay drawbridge.
- After crossing bridge, travel a half-mile and take a right at entrance to Millstone Nuclear Power Station (traffic light).
- Follow access road for a short distance and take first right and follow drive to end at Simulator Building Parking Area. This is the staging area for the field review.



DIRECTIONS TO HEARING LOCATION – From Millstone

WATERFORD TOWN HALL 15 Rope Ferry Road Waterford.

From Millstone, turn right onto Route 156. Follow Route 156 East approx. 2 ¼ mile. Entrance to Town Hall is on left at traffic light – across from school and before Route 1.

From I-95
Follow I-95 to Exit 82,
Follow Route 85 south.
Turn right on Jefferson Avenue.
Turn right on Chester Street.
Turn left on Clark Lane.
Turn left on Route 1.
Bear right on Route 156, parking lot is on left.
