The Connecticut Siting Council (Council) is in receipt of correspondence dated June 10, 2024 regarding compliance with Condition Nos. 1 and 2 of the Council's July 21, 2023 Partial Development and Management Plan II (Partial D&M Plan II) approval to submit staging/laydown area(s) and provisions for erosion and sedimentation controls and to submit the name and contact information for the spill response contractor and the local emergency community coordinator prior to commencement of construction for the above-referenced facility.

The Council acknowledges that Partial D&M Plan II Condition Nos. 1 and 2 have been satisfied. This acknowledgment applies only to the Partial D&M Plan II conditions satisfied by the June 10, 2024 correspondence. Requests for any changes to the D&M Plan shall be approved by Council staff in accordance with Regulations of Connecticut State Agencies (RCSA) §16-50j-62(b).

Please be advised that deviations from the Council's Decision & Order and D&M Plan approvals are enforceable under the provisions of Connecticut General Statutes § 16-50u. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to RCSA §16-50j-62.

Dear Ms. Bachman:

Pursuant to the Regulations of Connecticut State Agencies Section 16-50j-62(b)(2) and Attachment G to the project's Development & Management Plan, The United Illuminating Company ("UI") notifies the Council that a construction laydown area for the Project and the Spill Response Contractor/Regional Emergency Community Coordinator.

The Laydown yard will be located at 12 Division Street, Derby in Derby. The Laydown area is shown on the attached image. If additional laydown yards are identified, UI will notify the council accordingly.

The Company's Erosion and Sediment Control ("E&SC") plan will utilize Best Management Practices and proper erosion controls as required throughout the duration of the Company's use of the Laydown property. The Company does not believe that the location will require significant E&SCs since the property will be mostly milled/paved during the project. The property will not be used as a soil stockpile area and no subsurface disturbance is expected. The Company's E&SC controls will include:

- The installation and maintenance of filter sock around perimeter of detention pond, as needed.
- The installation and maintenance of inlet protection for all drainage on site, if needed.
- The use of dust control measures, if needed (i.e., water trucks). Equipment brought to and stored at the laydown area will be cleaned free of invasive species prior to mobilization from the project sites.
