NOTICE OF PUBLIC COMMENT SESSION

Pursuant to provisions of Connecticut General Statutes § 16-50m and Public Act No. 22-3, notice is hereby given that the Connecticut Siting Council (Council) will conduct a public comment session via Zoom remote conferencing on Wednesday, October 19, 2022, on the review of the Ten-Year Forecast of Connecticut Electric Loads and Resources and the 2022 Analysis of Life Cycle Costs of Electric Transmission Lines, beginning at 6:30 p.m.

Pursuant to CGS §16-50r, the Council shall hold at least one session of a public hearing no earlier than 6:30 p.m. The scope of the 2022 Forecast of Electric Loads and Resources review shall cover the 2022 utility forecast of loads and resources reports. The scope of the 2022 Life Cycle Cost Analysis shall cover all relevant electric transmission line life cycle costs. The Council will update the 2021 Forecast of Electric Loads and Resources and 2017 Life Cycle Cost Analysis, as necessary.

Interested persons must sign-up in advance to speak during the public comment session.
