NOTICE OF PUBLIC COMMENT SESSION

Pursuant to provisions of Connecticut General Statutes § 16-50m and 16-50r, notice is hereby given that the Connecticut Siting Council (Council) will conduct a public comment session via Zoom remote conferencing on Wednesday, November 15, 2023, on the review of the Ten-Year Forecast of Connecticut Electric Loads and Resources, beginning at 6:30 p.m.

The Council shall hold at least one session of a public hearing no earlier than 6:30 p.m. The scope of the review shall cover the 2023 utility forecast of loads and resources reports.

Interested persons must sign-up in advance to speak during the public comment session.
