Please be advised that during a public meeting of the Council held on November 14, 2013, the Council ruled that the final biennial Forecast Report would, going forward, be issued in the odd years.

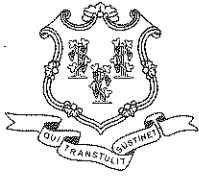

NOTICE OF HEARING ON CONNECTICUT FORECAST OF ELECTRIC LOADS AND RESOURCES

The Connecticut Siting Council (Council) will conduct a public hearing on Tuesday, June 24, 2014, to provide an opportunity for public comment on the 2014 Ten-Year Forecast of Connecticut Electric Loads and Resources. The hearing will be held in Hearing Room One, Ten Franklin Square, New Britain, Connecticut, beginning at 6:30 p.m., and thereafter as necessary.

Pursuant to CGS 16-50r, the Council shall hold a public hearing annually and at least one session of the hearing shall be held no earlier than 6:30 p.m. There will be no evidentiary hearing until 2015. The Council will issue a final biennial report in late 2015.

Any person who is not a participant in the proceeding may file a written statement with the Council at the hearing or any time up to 30 days thereafter. Such statements will become part of the record. A list of participants of record is available from the Council or on the Council's website at www.ct.gov/csc under "pending proceedings."

The record of this proceeding is available for public inspection at the office of the Council, 10 Franklin Square, New Britain, Connecticut 06051.

Requests for information in alternative formats or for sign-language interpreter services must be submitted in writing by June 17, 2014.
