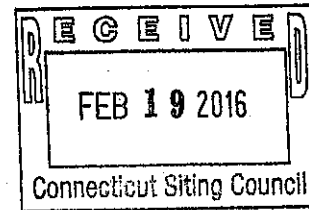

REPORT OF FORECAST OF LOADS AND RESOURCES

Capitol District Energy Center Cogeneration Associates

Pursuant to the provisions of Section 16-50r of the General Statutes, Capitol District Energy Center Cogeneration Associates (CDECCA) submits the following:

(1) A tabulation of estimated peak loads, resources and margins for each year.

CDECCA is owned by Pawtucket Power Holding Company LLC and operated by PurEnergy Operating Services at 490 Capitol Ave, CT 06106. The facility is a natural gas-fired, dual fuel capable, combined-cycle cogeneration plant. CDECCA provides peaking energy to the New England power market. CDECCA, as a wholesale power producer and cogeneration facility, does not have a need to forecast an estimated peak load requirement or margins, therefore no estimates have been offered.

(2) Data on energy use and peak loads for the five preceding calendar years.
