REPORT OF FORECAST OF LOADS AND RESOURCES Capitol District Energy Center Cogeneration Associates

Pursuant to the provisions of Section 16-50r of the General Statues, Capitol District Energy Center Cogeneration Associates ("CDECCA") submits the following:

(1) A tabulation of estimated peak loads, resources and margins for each year.

CDECCA is a natural gas-fired, dual fuel capable, combined-cycle cogeneration plant located at 490 Capitol Avenue, Hartford, Connecticut 06106 which provides peaking energy to the New England power market. CDECCA, as a wholesale power producer and cogeneration facility, is not required to forecast estimated peak load or margins.

(2) Data on energy use and peak loads for the five preceding calendar years.
