## 2023 BARROW SOLAR, LLC ANNUAL REPORT FOR THE CONNECTICUT SITING COUNCIL REVIEW OF TEN-YEAR FORECAST OF CONNECTICUT ELECTRIC LOADS AND RESOURCES

Pursuant to provisions of Section 16-50r of the Connecticut General Statutes, Barrow Solar, LLC ("Barrow") hereby submits this report of its ten-year forecast loads and resources. Each response is preceded by the requirement from that statute.

1) A tabulation of estimated peak loads, resources, and margins for each year.

The Barrow Solar facility has the capacity to generate 2.0 megawatts (MW) AC of electricity. As a wholesale power producer, Barrow does not have a franchise territory within which it would estimate peak load requirements or margins for the period, and therefore no such estimates are provided.

2) Data on energy use and peak loads for the five preceding calendar years.

Barrow received its permission to operate from the interconnection utility company (Eversource) on June 8, 2021. Prior to 2021, the facility was not operational. The 2022 power generated is 3,645 MWh, the 2023 total power is 3,308MWh, and the 2024 total power is 3,326MWh.

3) A list of existing generating facilities in service.

The facility is Barrow Solar LLC's sole power generating asset in Connecticut and has the capacity to generate 2.0 megawatts (MW) AC of electricity.

4) A list of scheduled generating facilities for which property has been acquired, for which certificates have been issued and for which certificates applications have been filed.
