Pursuant to § 16-50j-22a of the Regulations of Connecticut State Agencies, The United Illuminating Company (“UI”) respectfully requests and extension of time to June , 2022 to submit responses to the interrogatories issued by the Connecticut Siting Council (“Siting Council”) in this proceeding.
