### Dear Attorney Bachman:

This letter is to inform you of a pending non-material change in the indirect upstream ownership ("Transaction") of Kleen Energy Systems, LLC ("Kleen Energy"), the current owner and operator of the Kleen Energy Plant located in Middletown, Connecticut. Under the Transaction, a minority share of the indirect upstream ownership interests in Kleen Energy, currently held by Sojitz Corporation of America, will be sold to a wholly-owned subsidiary of ArcLight Energy Partners Fund VII, L.P. ("ArcLight"), a fund managed by ArcLight Capital Partners, LLC. The Transaction will not result in a change of control or an alternation to the day to day operations of the facility. Kleen Energy will remain responsible for any quarterly assessment charges under Conn. Gen. Stat. §16-50v(b)(2) that may be associated with this facility. The transaction will not result in any change in contact information for the individual or representative responsible for management and operations of the facility.

Please see <u>Attachment A</u> for organization charts showing the applicable entities pretransaction and post-transaction. Subject to the satisfaction of certain conditions, the Transaction is expected to close during the fourth quarter of 2023 (however, no assurances can be given as to if or when the Transaction will be completed). The parties will notify the Connecticut Siting Council of the actual date of the closing of the Transaction if and when it occurs.
