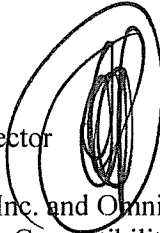

Dinner will be at Drescher's Restaurant at 25 Leavenworth Street. It is located diagonally across the street from City Hall.

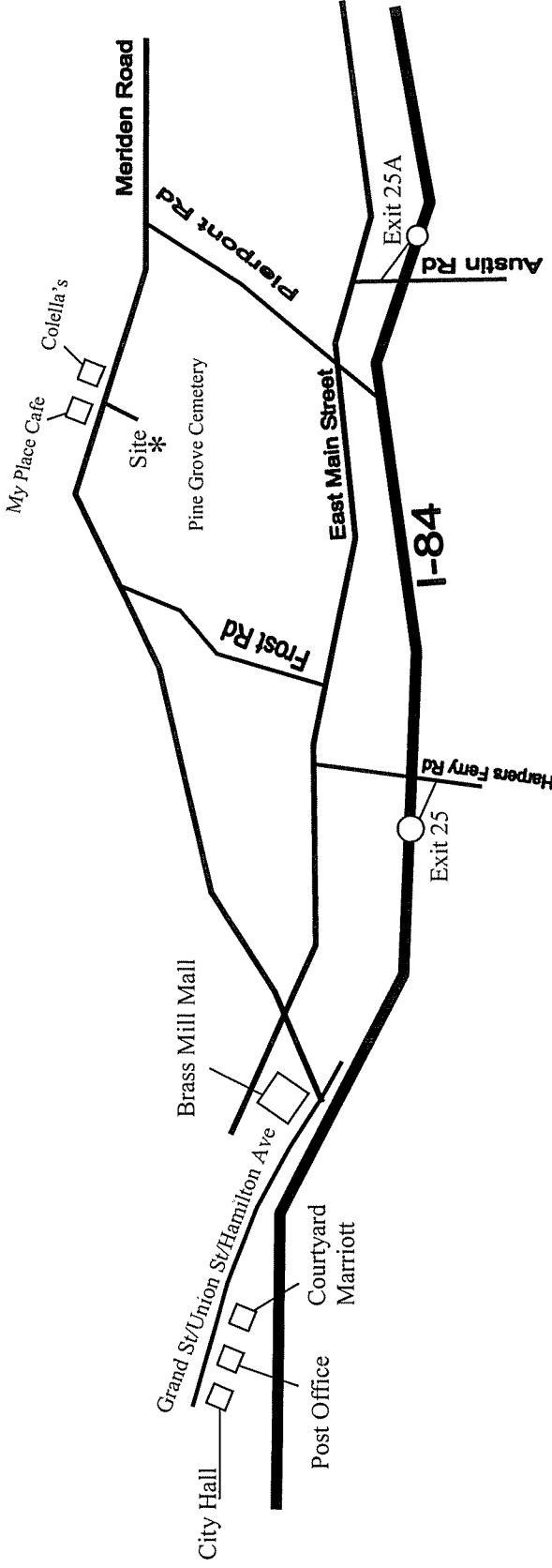

To Site

From East: Take I-84 west bound to Exit 25A (Austin Road); from exit ramp turn right onto Austin Road; at next intersection turn left onto East Main Street; follow to Pierpont Road and turn right (traffic light at intersection and gray condos ahead on right); follow Pierpont to stop sign and turn left onto Meriden Road; Pine Grove Cemetery will be on left across from Colella's Professional Accounting and My Place Café; inside cemetery, bear right to follow to office building; site is behind office building.

From West: Take Route 8 north or southbound to I-84; travel eastbound

on I-84 to Exit 25 (Reidville Dr, Scott Rd, or Harpers Ferry Rd); at end of exit ramp turn left onto Harpers Ferry Road; from Harpers Ferry, turn right onto East Main Street and then take first left onto Frost Road; follow to Meriden Road and turn right onto Meriden Road; Pine Grove Cemetery will be on right across from My Place Café and Colella's Professional Accounting; inside cemetery bear right to office building; site is behind office building.

To Hearing

From Pine Grove Cemetery, turn left onto Meriden Road; follow to

Hamilton Avenue (I-84 will be directly ahead and Brass Mill Mall will be on right) and turn right onto Hamilton; follow signs to downtown; Hamilton will turn into Union Street which will lead into Grand Street; City Hall is on left on Grand Street after Courtyard Marriott and Post Office.

To Dinner:

Dinner is at Drescher's. The restaurant is located diagonally across the street from City Hall on Leavenworth Street.
