Dinner will be at the Oak Street Café on Oak Street in downtown Manchester (see map).

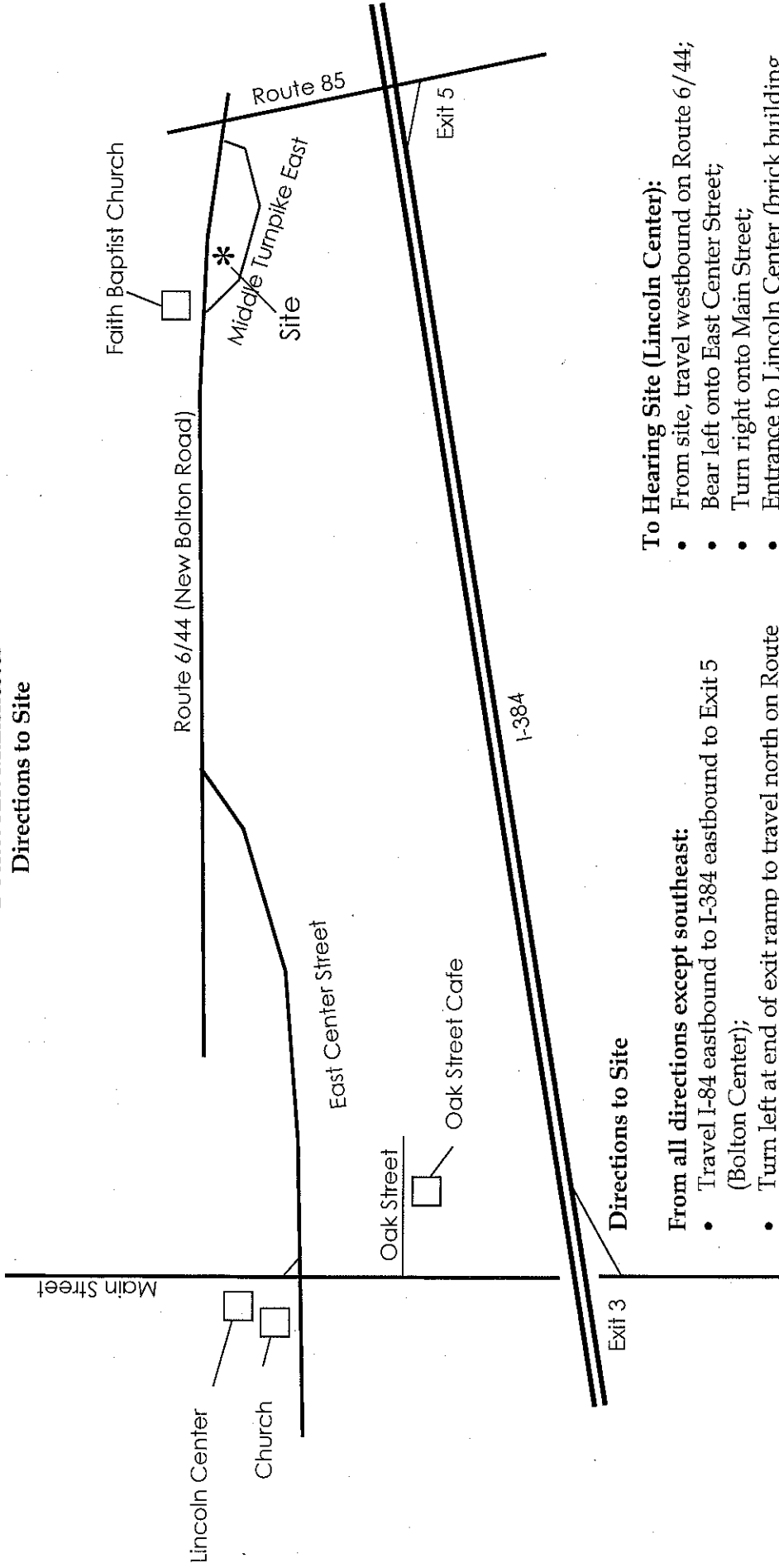

Directions to Site

From all directions except southeast:

- Travel I-84 eastbound to I-384 eastbound to Exit 5 (Bolton Center);
- Turn left at end of exit ramp to travel north on Route 85;
- Turn left at intersection of Rt 85 and Routes 6&44 (at traffic light);
- Turn left onto Middle Turnpike East opposite Faith Baptist Church; look for traffic cones at parking area.

From southeast:

- Travel Route 2 westbound to Exit 10 to travel northbound on Route 83 to I-384;
- Get onto I-384 eastbound to Exit 5, then follow above directions.

To Hearing Site (Lincoln Center):

- From site, travel westbound on Route 6/44;
- Bear left onto East Center Street;
- Turn right onto Main Street;
- Entrance to Lincoln Center (brick building, behind church on corner) is shortly on left.

To Dinner:

- Dinner will be at Oak Street Café on Oak Street.
- From Lincoln Center, travel south on Main Street;
- Turn left onto Oak Street in Manchester's downtown area;
- Restaurant will be about a block on right.
