From Interstate 91

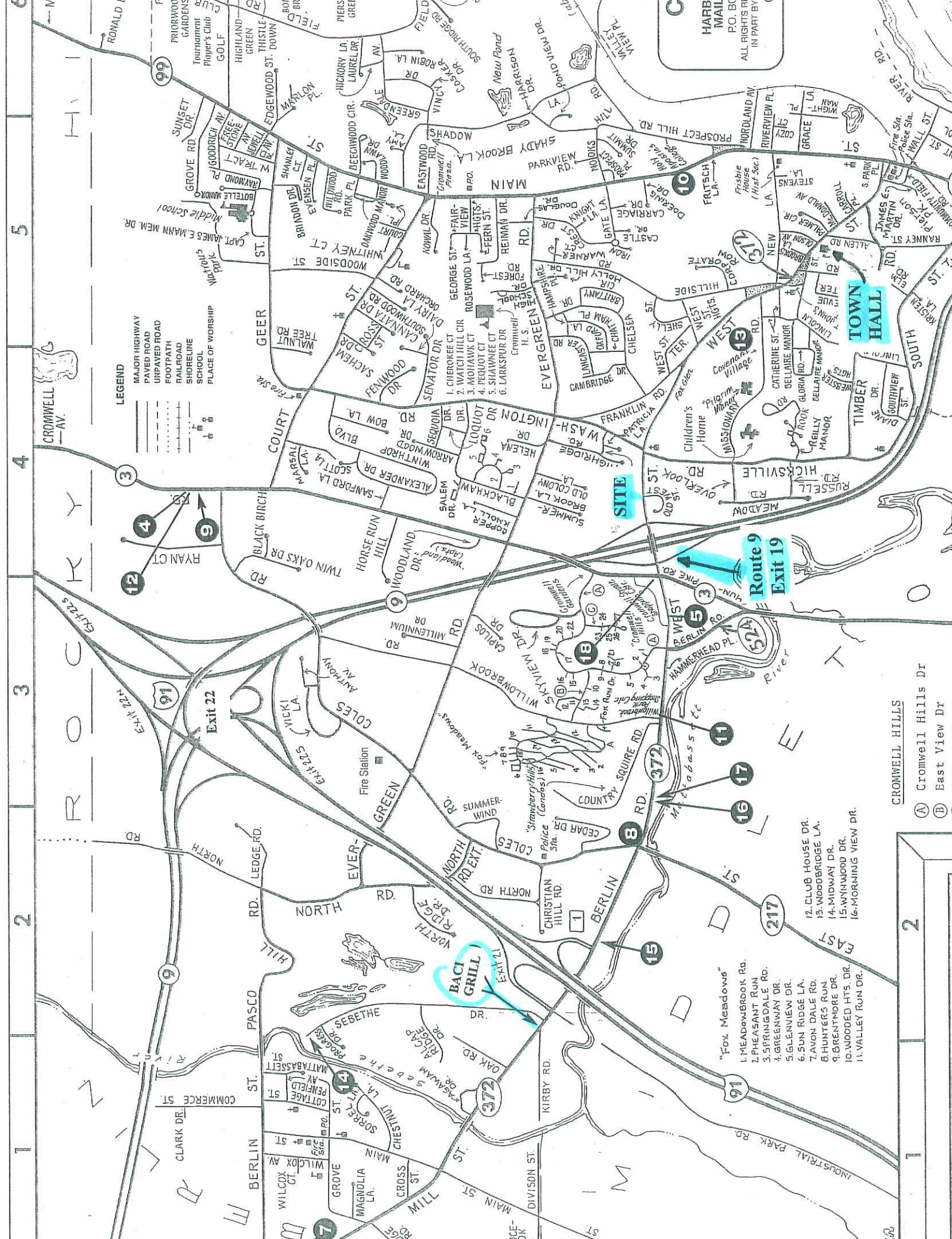
Follow Interstate 91 to Exit 22 for Route 9 South.
