

PUBLISHER'S CERTIFICATE

NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council ("Siting Council") on July 28, 2007 or thereafter by MCF Communications bg, Inc. and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. d/ba/ T-Mobile (the "Co-Applicants"). The Co-Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Thompson, Connecticut. The Co-Applicants are proposing to construct a new monopole tower on an approximately 8 acre parcel located at Rich Road in Thompson and owned by the Town of Thompson (the "Property"). The Co-Applicants propose to construct a new 150' self-supporting monopole tower and antennas in the northeastern portion of the Property. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g et. seq.

The proposed facility would provide personal wireless communication service along Interstate I-395, in portions of the Town of Thompson and surrounding areas, which do not have adequate service. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the Town of Thompson. The balloon will be flown from approximately 12 p.m. to 6 p.m. on the day of the hearing. Notice of the public hearing date will be provided by the Siting Council.
