I, Jean Ann Campbell being duly sworn, hereby depose and say:

1. I am over eighteen years of age and believe in the obligations of an oath.
2. I am personally familiar with the facts set forth in this Affidavit.
3. I am the executrix of the Estate of Edward Drzal. Edward Drzal was my father.
4. The Estate of Edward Drzal is the owner of property located at 425 Litchfield Road in New Milford, Connecticut (the "Property").
5. Edward Drzal died in 2007.
6. Attached hereto as Exhibit 1 are photographs of the Property at or about the time of Edward Drzal's passing. As can be seen, the Property was in a state of disrepair and had accumulated old equipment, granite and miscellaneous materials.

7. In addition, Edward Drzal had been issued zoning violation letters because of the materials accumulated on the Property.

8. When I became executrix of the estate, which owns the Property, I had conversations with various town officials who were very interested in ensuring that the Property was cleaned up and brought into zoning compliance.

9. Since I became the executrix of the estate, which owns the Property, I have undertaken to clean up the Property.


10. To date, the estate has spent almost \$80,000 in removing debris and materials from the Property.

11. I plan on improving the Property with a farm stand and cider mill, which will be a benefit to the Town of New Milford and its residents.

12. Attached hereto as Exhibit 2 are recent photographs of the Property. As can be seen, a significant amount of clean-up has occurred on the Property.


13. I intend on completing the cleanup of the Property by the end of 2008.

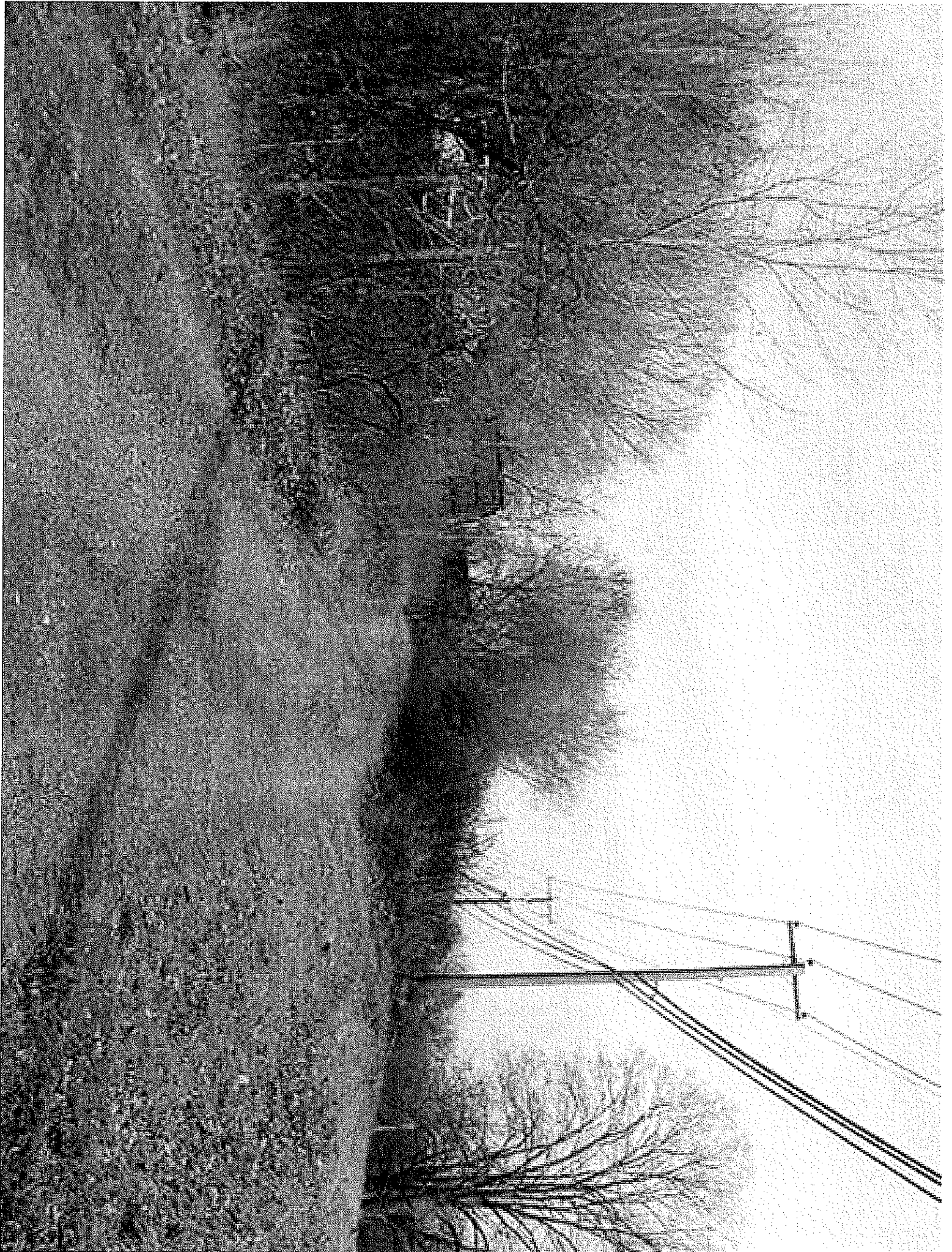


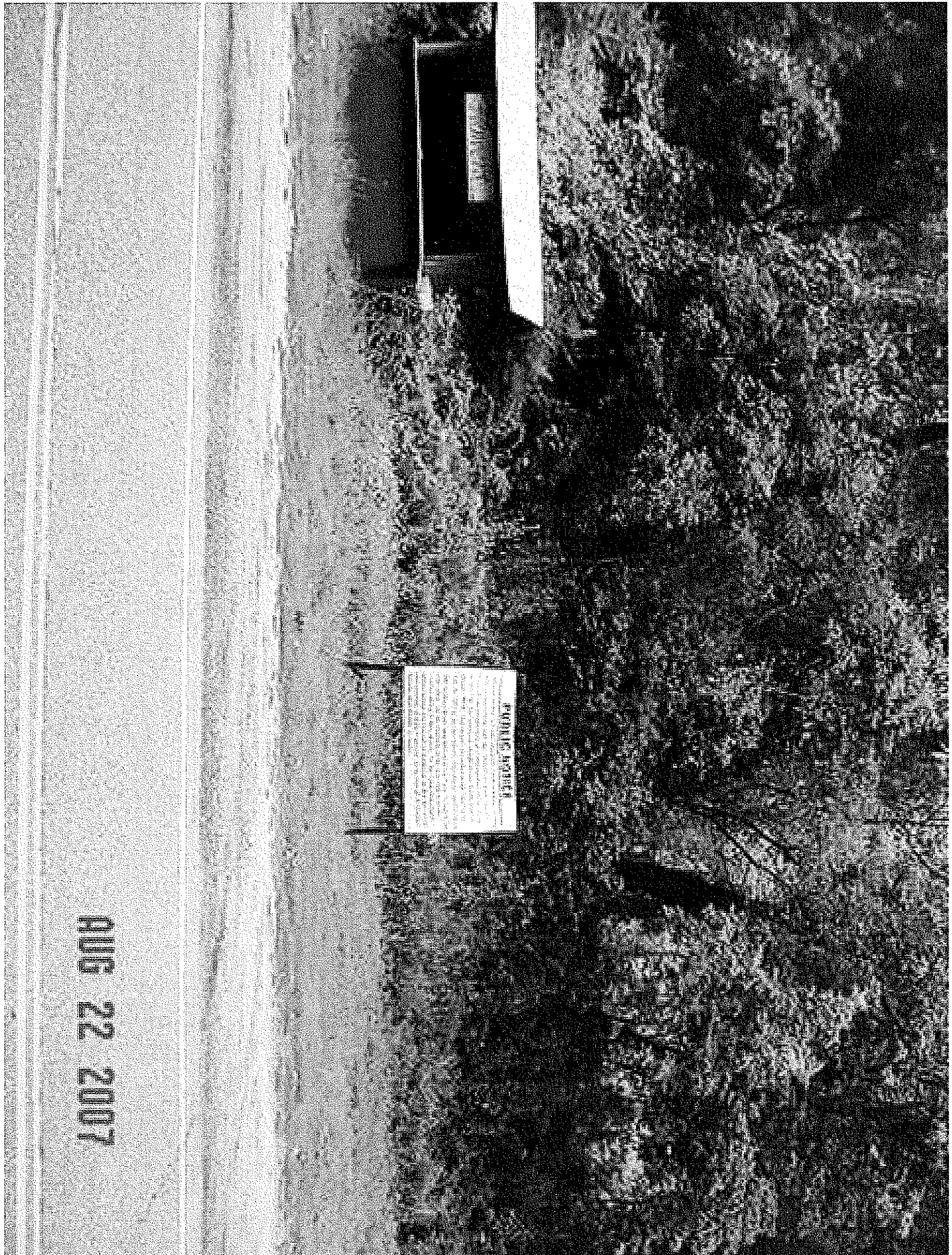
