Richard Pinto being duly sworn, states:

1. I am a Senior Project Manager, Substation Projects for The United Illuminating Company (“UI” or the “Company”), 180 Marsh Hill Road, Orange, Connecticut. I am over the age of eighteen years and understand the obligation of making statements under oath.
2. I am familiar with the Siting Council’s Docket No. 490 concerning the Company’s application for Certificate of Environmental Compatibility and Public Need for the rebuild of the Old Town Substation.
3. I was responsible for the posting of the “Public Notice Sign” at 312 and 330 Kaechele Place, Bridgeport, Connecticut (the “Site”). Pursuant to Section 16-50j-21 of the Regulations of Connecticut State Agencies, the sign was erected on September 24, 2020. The sign measures four feet by six feet and reads:
