- Week of 1/22/2024 Work completed on exterior brick façade of the building.
- Week of 1/29/2024 Work began on exterior roofing/trim of the building.
- Week of 2/5/2024 Work completed on exterior roofing/trim of the building.

<sup>&</sup>lt;sup>1</sup> On May 23, 2023, Cellco notified the Council that construction for the proposed facility would commence on or about June 6, 2023. However, construction did not actually start until July 3, 2023. Construction activity associated with the Facility has taken longer due to the need for Cellco to avoid disruption of ongoing activity on the Sacred Heart University main campus. Cellco anticipates construction to be completed this summer when SHU is out of session.

- Week of 2/12/2024 Work began on interior insulation and trim.
- Week of 2/19/2024 Work began on installing the generator for shared use.
- Week of 2/26/2024 Work began on interior sheet rock/taping.
- Week of 3/18/2024 Work began on installing Storm Tech.
- Week of 3/25/2024 -Work began on installing Meter Center and feeders to transformer.
- Week of 4/1/2024 Work began on installing telephone conduits.
- Week of 4/8/2024 Work completed on installing telephone conduits.
- Week of 4/15/2024 Work began on installing garage doors on building.
- Week of 5/6/2024 Work continued on shelter interior sheetrock and tape;
- Week of 5/13/2024 Continue telephone conduit installation; install exterior doors and VCT flooring in cell rooms.
- Week of 5/27/2024 Finish telephone conduit installation and interior shelter painting; energize electric service to building, Verizon electrical panel and interior fixtures.
