Directions to 701 Lydall Street, Manchester, Connecticut.

From Hartford, New Britain, Enfield, Meriden, Stamford, Milford, and Salisbury:

- Take I-84 eastbound to I-384 in East Hartford and switch onto I-384 to continue traveling eastbound.
- From I-384, take Exit 5 Bolton/Colchester/Route 85; turn left at end of exit ramp onto 85
 North Bolton Center Road
- At intersection with Route 6, continue straight ahead to stay on 85 North.
- At first stop sign after crossing Route 6, turn right onto Lake Road.
- From Lake Road, turn left onto Lydall Street, immediately after sign marking Vernon town line.
- Site will be on right after approximately .3 mile. Entrance is through an opening in a fence look for the public hearing sign.

From Stonington

- Take Route 2 northbound toward Hartford to Exit 10 E. Glastonbury/Manchester/Route 83; take exit and follow Route 83 north to I-384 in Manchester.
- At intersection of Route 83 and I-384, enter I-384 to travel eastbound toward Providence.
- From I-384, follow directions above.

To Hearing/Lincoln Center from Site

- From the site, turn right onto Lydall Street.
- Follow Lydall Street to stop sign at Vernon Street and turn left, stay on Vernon Street after turning.
- Follow Vernon Street to traffic light and turn right onto Middle Turnpike East.
- On Middle Turnpike East, there will be another traffic light in .1 mile; here bear left onto East Center Street Route 6/44.
- From East Center Street, turn right onto Route 83/Main Street; Lincoln Center will be immediately to the left.

From Lincoln Center to Restaurant

Dinner will be at the Main Pub, 306 Main Street in Manchester, 860-647-1551, located .4 mile north of Lincoln Center at the corner of Main Street and Middle Turnpike opposite Walgreen's. From Lincoln Center, turn left onto Main Street.
