I. Introduction

The request for a feasibility proceeding is from New Cingular Wireless, PCS, LLC (AT&T), pursuant to Connecticut General Statutes §16-50aa(c)(2), for the shared use of an existing facility in the City of Middletown, Connecticut.

II. Technical

The request for a feasibility proceeding is consistent with the requirements of Connecticut General Statutes §16-50aa(c)(2). This proceeding would not require an outside consultant.

III. Administrative Review

All service and filing requirements pursuant to Connecticut General Statutes §16-50aa(c)(2) have been fulfilled.

IV. Procedural

Pursuant to Connecticut General Statutes §16-50aa(c)(2), the Council shall hold a public hearing not later than 90 days following the Council's receipt of a request for a feasibility proceeding. In accordance with CGS § 16-50m and Sections 149-150 of Public Act No. 21-2, staff recommends holding a remote public hearing via Zoom conferencing on February 17, 2022 and depositing the transcript in the Middletown City Hall.
