Field Review Meeting Location:

40 Grassy Hill Road, East Lyme

Hearing Location:

East Lyme Town Hall, 108 Pennsylvania Avenue (Rt. 161), Niantic

TO FIELD REVIEW

From Hartford Area

Follow I-84 to Route 2 south.

Follow Route 2 south to Exit 19 – Bear right onto Route 11 south.

Follow Route 11 to end at Route 82.

Take left onto Route 82 and proceed to traffic light.

Turn right onto Route 85 and follow Route 85 south into Chesterfield.

At traffic light in Chesterfield, turn right onto Grassy Hill Road.

Follow Grassy Hill Road approx. 1.3 miles to #40 driveway on left.

Follow driveway past house, continuing straight to rear field area.

Park in field on left.

From Middletown - Route 9 South

Follow Route 9 south to Interstate 95 north in Old Saybrook.

Follow Interstate 95 north to Exit 74, Route 161.

Follow directions from Route 161 below.

From New Haven - Interstate 95 North

Follow Interstate 95 north to Exit 74.

Follow directions from Route 161 below.

From New London – Interstate 95 South

Follow Interstate 95 south to Exit 74.

Follow directions from Route 161 below.

From Route 161 (at I-95 exit)

At end of I-95 exit ramp, take left onto Route 161 north.

Follow Route 161 north approx. 3.4 miles and turn left onto Walnut Hill Road.

Follow Walnut Hill Road to T intersection at stop sign.

Turn right onto Grassy Hill Road.

Turn into first driveway on the right (#40)

Follow driveway past house, continuing straight to rear field area.

Park in field on left

From driveway, turn left onto Grassy Hill Road.
Turn left onto Walnut Hill Road.
At end of Walnut Hill Road, turn right onto Route 161, going south.
Follow Route 161 south past I-95 and into Niantic.
Town Hall is on right, approx. a half-mile past SUNOCO.

From Interstate 95

Take Exit 74 for Route 161.
Follow Route 161 south.
Town Hall is on right, approx. a half-mile past SUNOCO.
