The Connecticut Light and Power Company ("CL&P") hereby applies pursuant to Conn. Gen. Stat. §16-50n (6) and R.C.S.A. §16-50j -15a to be designated as an intervenor in this proceeding. In support of this application, CL&P states as follows:

1. CL&P is a specially chartered Connecticut corporation, with offices at 107 Selden Street, Berlin, Connecticut, and a public service company as defined in §16-1 of the Connecticut General Statutes.

2. CL&P operates and maintains transmission and distribution facilities throughout the State of Connecticut, providing service to approximately 1.1 million customers. CL&P is affected by this proceeding in that the proposed project has potential impacts on the Connecticut electric transmission system, particularly including CL&P's transmission facilities.

Manner in Which the Petitioner is Substantially and Specifically Affected.

3. CL&P is the electric transmission service provider for the proposed project and the project will have to interconnect with the CL&P transmission system. As such, it has an interest and contributions to provide the Council's regarding the interconnection requirements for the proposed project.
