PRE-HEARING SUBMISSION OF PLAINFIELD RENEWABLE ENERGY LLC

Plainfield Renewable Energy LLC ("PRE") hereby submits its response to the July 16, 2008 Hearing Procedure memorandum issued by the Connecticut Siting Council (the "Council") in preparation for the August 14, 2008 hearing before the Council on the Friends of the Quinebaug River's ("FQR") motion to reopen the Council's declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed construction, maintenance, and operation of a 37.5 megawatt wood biomass fueled gasification power plant (the "Project") in Plainfield, Connecticut, issued by the Council on June 7, 2007, as Petition No. 784. This hearing is being held to hear evidence as to whether conditions have changed such that the Council should conduct further proceedings to examine whether its original decision should be reversed or modified.

I. Witnesses

PRE currently expects the following individuals to be witnesses at the hearing:

- 1. Mr. Daniel J. Donovan, managing member of NuPower LLC, 20 Marshall Street, Suite 300, Norwalk, CT 06854, and joint owner of PRE. Mr. Atkin's résumé is attached as Attachment 2.
- 3. Other witnesses may be called, as necessary, to respond to interrogatories or Council questions at the hearings, or to address matters raised by participants, parties or intervenors.

II. Pre-Filed Testimony

PRE is not filing pre-filed testimony.

PRE asks the Council to take administrative notice of the record in Petition 784 and in particular the Council's June 7, 2007 decision, opinion, and findings of fact, and PRE's Brief in Opposition to FQR's motion to reopen Petition 784.
