RE: **PETITION NO. 805** - Ansonia Generation LLC petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed construction, maintenance, and operation of a 58.4 MW combined heat and power natural gas-fired electric generating facility and transmission line tap located at 75 Liberty Street, Ansonia, Connecticut.

The Connecticut Siting Council has scheduled a field review for this petition for Wednesday, May 9, 2007, beginning at 2:00 p.m. Council members will meet at the proposed site at 75 Liberty Street in Ansonia. Travel via I-84 West

Merge onto Route 8 South via exit 19 (On the left)

Follow Route 8 South

Take Exit 19 (Route 334) turn left at stop sign onto Route 334 (Great Hill Road)

Stay straight on Route 334 East (Wakelee Ave.)

Bear left, at stop sign after Nolan Athletic Complex, staying on Route 334 (Franklin Street)

At the stop sign turn left onto Route 334 (Maple Street)

Cross the Naugatuck River

At the stop light turn left onto Main Street

At the next stop light turn left onto North Main Street (the turn is before the paved triangle in the road)

Take first left onto Third Street (Daily Mart is on the corner)

Take next left onto Liberty Street (which is one way)

Travel via I-95 South

Follow to Ansonia City Hall #253 Main Street on left side of street.
Enter narrow driveway on the right side of the building and follow through to the intersecting street. A parking lot is straight across the street.

From the Hartford/Waterbury area (Mr. Emerick, Mr. Wilensky and Mr. Ashton)

Travel via I-84 West

Merge onto Route 8 South via exit 19 (On the left)

Follow Route 8 South

Take Exit 19 (Route 334) turn left at stop sign onto Route 334 (Great Hill Road)

Bear left, at stop sign after park, staying on Route 334 (Franklin Street)

Cross the Naugatuck River

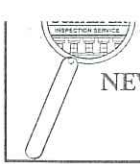

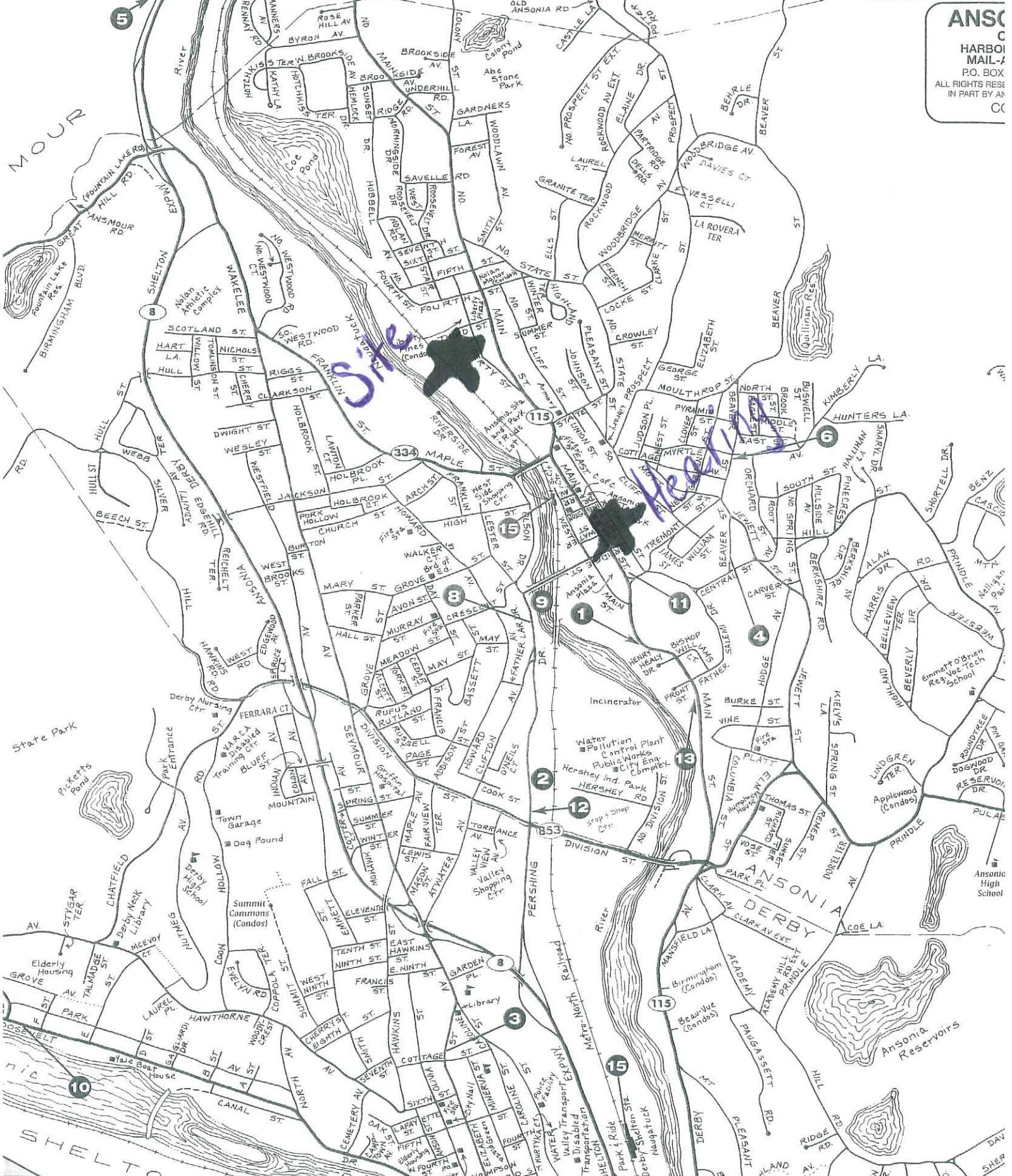
