Directions to Site

Site is located at 82 Lovely Street (Route 177) in the Unionville section of Stonington.

From Hartford and Enfield

- Take I-84 westbound to Exit 39 (Route 4 – Farmington)
- Follow Route 4 (Farmington Avenue) through Farmington to intersection with Route 177 in the center of Unionville
- Bear right at intersection to follow Route 177 northbound
- Site will be a short distance on right

From New Britain

- Take Route 72 westbound to Exit 1 (Route 177 – N. Washington Street)
- Turn right at end of exit ramp and follow Route 177 northbound to intersection with Route 4 in center of Unionville
- At intersection, continue straight ahead to stay on Route 177
- Site will be a short distance on right

From Meriden

- Take I-91 northbound to Route 9 westbound to Route 72 westbound and follow to Exit 1 (Route 177 – N. Washington Street)
- Turn right at end of exit ramp and follow Route 177 northbound to intersection with Route 4 in center of Unionville
- At intersection, continue straight ahead to stay on Route 177
- Site will be a short distance on right

From Stonington

- Travel to New Britain, in New Britain switch from Route 9 to Route 72 westbound and follow to Exit 1 (Route 177 – N. Washington Street)
- Turn right at end of exit ramp and follow Route 177 northbound to intersection with Route 4 in center of Unionville
- At intersection, continue straight ahead to stay on Route 177
- Site will be a short distance on right

From Wolcott

- Take I-84 eastbound to Route 72 westbound (Exit 33 on I-84) and follow to Exit 1 (Route 177 – N. Washington Street)
- Turn right at end of exit ramp and follow Route 177 northbound to intersection with Route 4 in center of Unionville
- At intersection, continue straight ahead to stay on Route 177
- Site will be a short distance on right

From Fairfield and Milford

- Take Route 8 northbound to I-84 eastbound to Route 72 westbound (Exit 33 on I-84) and follow to Exit 1 (Route 177 – N. Washington Street)
- Turn right at end of exit ramp and follow Route 177 northbound to intersection with Route 4 in center of Unionville
- At intersection, continue straight ahead to stay on Route 177
- Site will be a short distance on right

From Norfolk

- Take Route 44 eastbound to Route 177 in Canton (right turn opposite Ethan Allen store)
- Follow Route 177 southbound to site — it will be on left, shortly before Route 4 intersection

To Hearing from Site

Hearing will be in the Meeting Room of the Farmington Library, 6 Monteith Drive, Farmington.

- From site, turn left onto Lovely Street (Route 177)
- At intersection with Route 4, turn left onto Route 4 (Farmington Avenue)
- Follow Route 4 to Monteith Drive and turn left into Town of Farmington municipal complex (there will be a traffic light)
- Library is first building on left

To Restaurant

Dinner will be at George's Restaurant, 9 School Street, Unionville (860/673-0421).

- From Monteith Drive, turn right onto Route 4 and follow to intersection with Route 177
- At intersection, go straight ahead onto School Street (left side of Civil War Monument)
- Take first driveway on left to George's Restaurant
