229 Church Street, Naugatuck, CT
3:00 p.m. and 7:00 p.m.

DIRECTIONS TO FIELD REVIEW – 880 Andrew Mountain Road, Naugatuck

To Proposed Site From Fairfield and Stonington Areas

Travel via Route 8 North to exit 26 (Route 63)
Turn left at the end of the ramp onto Route 63 North
Follow Route 63 North
After crossing the Naugatuck River go straight through the first stoplight intersection
At the second stoplight intersection turn left onto Scott Street (up a hill)
Turn left onto Andrew Avenue
Turn right onto Andrew Mountain Road
Follow Andrew Mountain Road for approximately 1.4 miles to site
Site will be on left (after Tower Road)

To Proposed Site From Waterbury and Hartford areas

Travel via Route 8 South to exit 26 (Route 63)
Turn right at the end of the ramp onto Route 63 North
Follow Route 63 North
After crossing the Naugatuck River go straight through the first intersection
At the second intersection turn left onto Scott Street (up a hill)
Turn left onto Andrew Avenue
Turn right onto Andrew Mountain Road
Follow Andrew Mountain Road for approximately 1.4 miles to site
Site will be on left (after Tower Road)

DIRECTIONS TO HEARING LOCATION – Naugatuck Town Hall 4th Floor, Hall of Burgesses, 229 Church Street, Naugatuck, CT

To Hearing Location from the proposed site

Follow Andrew Mountain Road
Turn left onto Andrew Avenue
Turn right onto Rubber Avenue
Follow Rubber Avenue (past the Rite Aid Pharmacy)
Turn left onto Church Street
Town Hall is on the right just after Maple Street
Take driveway just after the Town Hall Building

To Hearing Location from the Fairfield and Stonington Areas

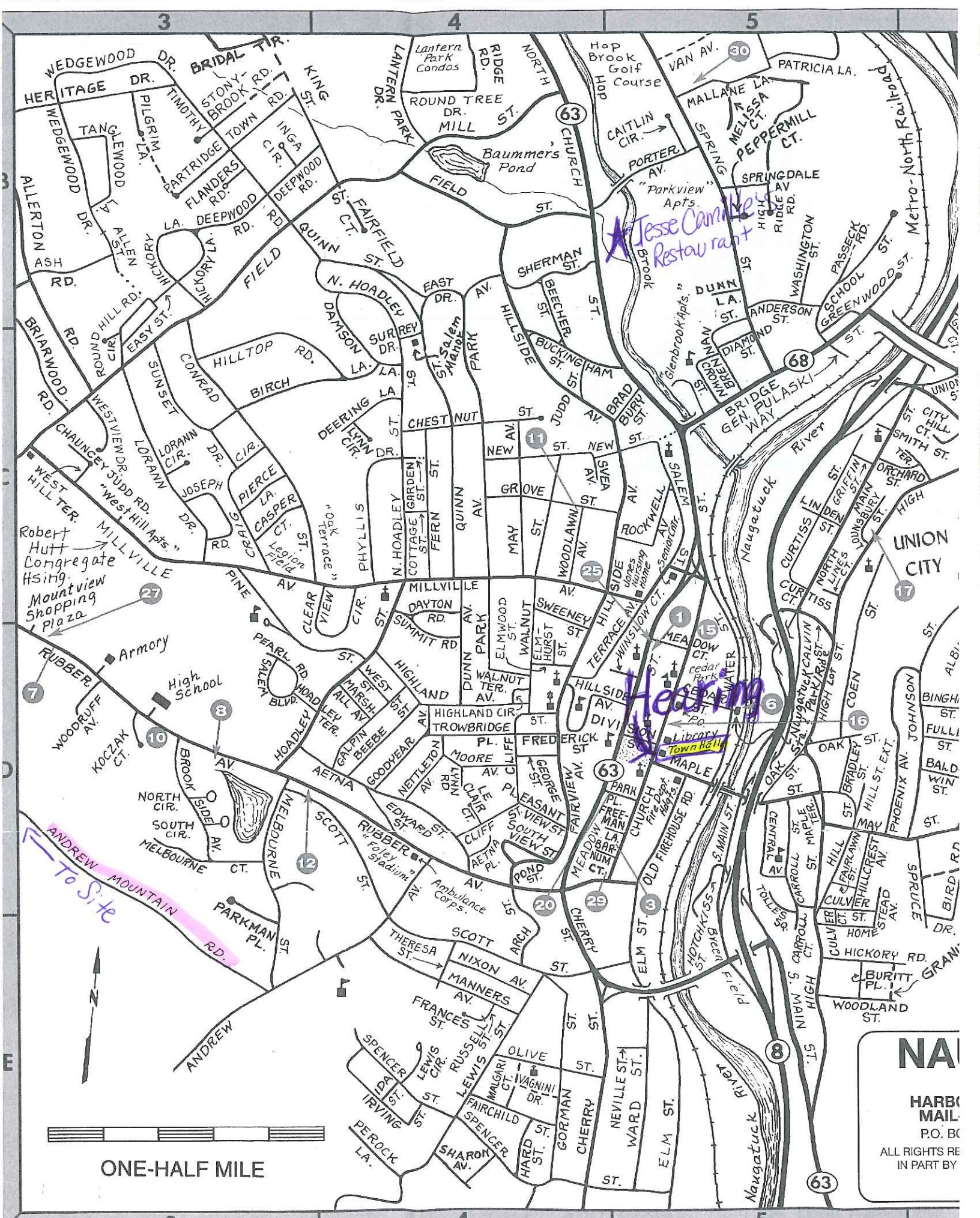
Travel via Route 8 North
Take Exit #26 (South Main Street)
Turn left at the end of the ramp. You will be on Route 63 North
Proceed over the Bridge (Naugatuck River)
Continue on Route 63 through FOUR (4) traffic lights
At the FOURTH traffic light turn right onto Division Street
(Congregational Church on your left, Town Green on your right)
At the stop sign you will be facing the Naugatuck Town Hall
Proceed straight into the driveway

To Hearing Location from the Waterbury and Hartford Areas

Travel via Route 8 south to Exit #27 Maple Street
Turn right at the end of the exit onto Maple Street
Proceed over Whittemore Bridge (Naugatuck River)
Continue straight to second traffic light (you will be facing the Town Green)
Naugatuck Town Hall will be on your right
Turn right onto Church Street
The first driveway on your right will be the Town Hall Driveway

Recommended restaurant: Jesse Camille's Restaurant, 615 North Church Street

From Hearing Location:
Straight out of the Town Hall driveway onto Division Street
Turn right onto Meadow Street (Route 63)
Follow Route 63 (which will become North Church Street)
Restaurant will be on the right across from Irving Gas Station
Driveway is accessed from Porter Avenue
