NORTH ATLANTIC TOWERS, LLC AND NEW CINGULAR WIRELESS PCS LLC (AT&T) RESPONSES TO SITING COUNCIL INTERROGATORIES

- Q.1. Please provide the cover letter sent to adjacent property owners provided in a list entitled "Adjacent Property Owners" received by the Council on December 6, 2010.
- A.1. Attached in Exhibit A is the list of adjacent property owners, certification of service dated December 2, 2010 and a copy of the letter that was sent on December 2, 2010 to the adjacent property owners listed therein.
- Q.2. Have any comments been received from nearby landowners on the proposed project?
- A.2. One abutter, Mr. Paul Aexio, called and inquired about the access road and drainage. It was noted that the proposed access drive is designed to maintain the grades and associated drainage patterns of the existing site. Since the proposed access drive will be constructed from gravel, a pervious material, the existing runoff rate will not noticeably increase. As such, the proposed access drive will not adversely impact the existing drainage conditions.
- Q.3. Who is the current owner of the existing tower? Who is responsible for removal of the existing tower?
- A.3. The property owner, Franklin B. Andrew, owns the existing tower. North Atlantic Towers will be responsible for the removal of the existing tower.
- Q.4. Has the tower owner been notified of the proposed replacement?
- A.4. Yes.
- Q.5. Can AT&T flush mount antennas proposed for the new tower?
- A.5. Yes, AT&T can flush mount its antennas. However, flush mounted antennas would require at least two additional levels of antennas on the monopole in order to accommodate the proposed AT&T antennas. Cumulatively, flush mounted antennas would result in three levels of antennas for AT&T at 120', 130' and 140' AGL.

- Q.6. Could AT&T construct the new compound and replacement tower south of the existing site?
- A.6 Yes, North Atlantic Towers could construct the proposed facility south of the existing site, provided that the location is acceptable to the property owner.
- Q.7. Could AT&T use the existing driveway for the 880 and 860 Andrew Mountain Road property for access to the site, rather than the proposed access road along the northern boundary of the property?
- A.7. North Atlantic Towers initially reviewed use of the existing driveway for access to the replacement facility with the property owner. However, the property owner noted that the route to the replacement facility via the existing access drive would interfere with his use of the property and as such, requested that an alternative route be investigated.
- Q.8. Is AT&T located on any of the structures listed behind Tab 3 of the Supplemental Submission? What sites and at what height?
- A.8. Yes, AT&T is located on some of the existing facilities/structures within approximately four miles of the replacement facility. Please see the table included in Exhibit B.
- Q.9. What are the addresses of the towers listed behind Tab 3 of the Supplement Submission?
- A.9. Attached in Exhibit B is an updated map and table with addresses of existing structures and towers within approximately four miles of the replacement facility.
- Q.10. Who owns the property to the north on Tower Lane that contains the nearest residence?
- A.10. The closest residential structure is located approximately 273' to the north of the existing tower and the proposed replacement tower with an address of 41 Tower Lane. Per the Borough of Naugatuck Tax Assessors' records, this property is owned by Enio and Maria Martins.

We are writing to you at the request of the State of Connecticut Siting Council with respect to the above referenced matter.

Our clients, North Atlantic Towers and AT&T, have petitioned the Siting Council for approval to replace an existing 100' unused lattice tower located at 880 Andrew Mountain Road in the Borough of Naugatuck (Petition No. 973). The replacement facility is needed by AT&T to provide its services in this area of Naugatuck. The existing 100' lattice tower will be replaced with a 120' monopole in the same location as the existing lattice tower. A 75' x 75' fenced equipment compound will be installed at the base of the replacement monopole. AT&T will install six panel antennas at the 120' level of the replacement monopole along with an associated 12' x 20' unmanned equipment shelter within the equipment compound. Vehicular access to the facility will be provided from Andrew Mountain Road along the northern property boundary over a new 15-foot wide gravel access drive. Enclosed for your convenience is a copy of the plans that were submitted to the Siting Council and detail the proposed replacement facility.


