RE: **PETITION NO. 980** - BNE Energy, Inc. petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, maintenance, and operation of a 3.2 MW Wind Renewable Generating facility located at 178 New Haven Road, Prospect, Connecticut.

**Field Review participants - meet at hearing location at 1:45 p.m. for carpool:
Long River Middle School, 38 Columbia Avenue, Prospect**

Via Interstate 84 (Hartford, New Britain, Meriden, Waterbury areas)

Follow I-84 to Exit 23 in Waterbury (Route 69).
Follow Route 69 south into Prospect.
Turn left onto Columbia Ave just before the Route 68 - Route 69 intersection.
Follow to school. Parking area is to right.

Via Route 8 (Stratford, Ansonia areas)

Follow Route 8 to Exit 28 (Route 68).
Go straight off exit, and straight through intersection (staying on Union City St.)
At next light, turn right onto Route 68 east.
Follow Route 68 east into Prospect.
At intersection with Route 69, turn left onto Route 69 and immediately turn right
onto Columbia Ave.
Follow to school. Parking area is to right.

Via I-91 (New Haven area)

Follow I-91 north to Exit 10 (Route 40).
Follow Route 40 north to Route 10 north.
Follow Route 10 north to Route 68.
Follow Route 68 west to Prospect.
At intersection with Route 69, turn right onto Route 69 and immediately turn right
onto Columbia Ave.
Follow to school. Parking area is to right.

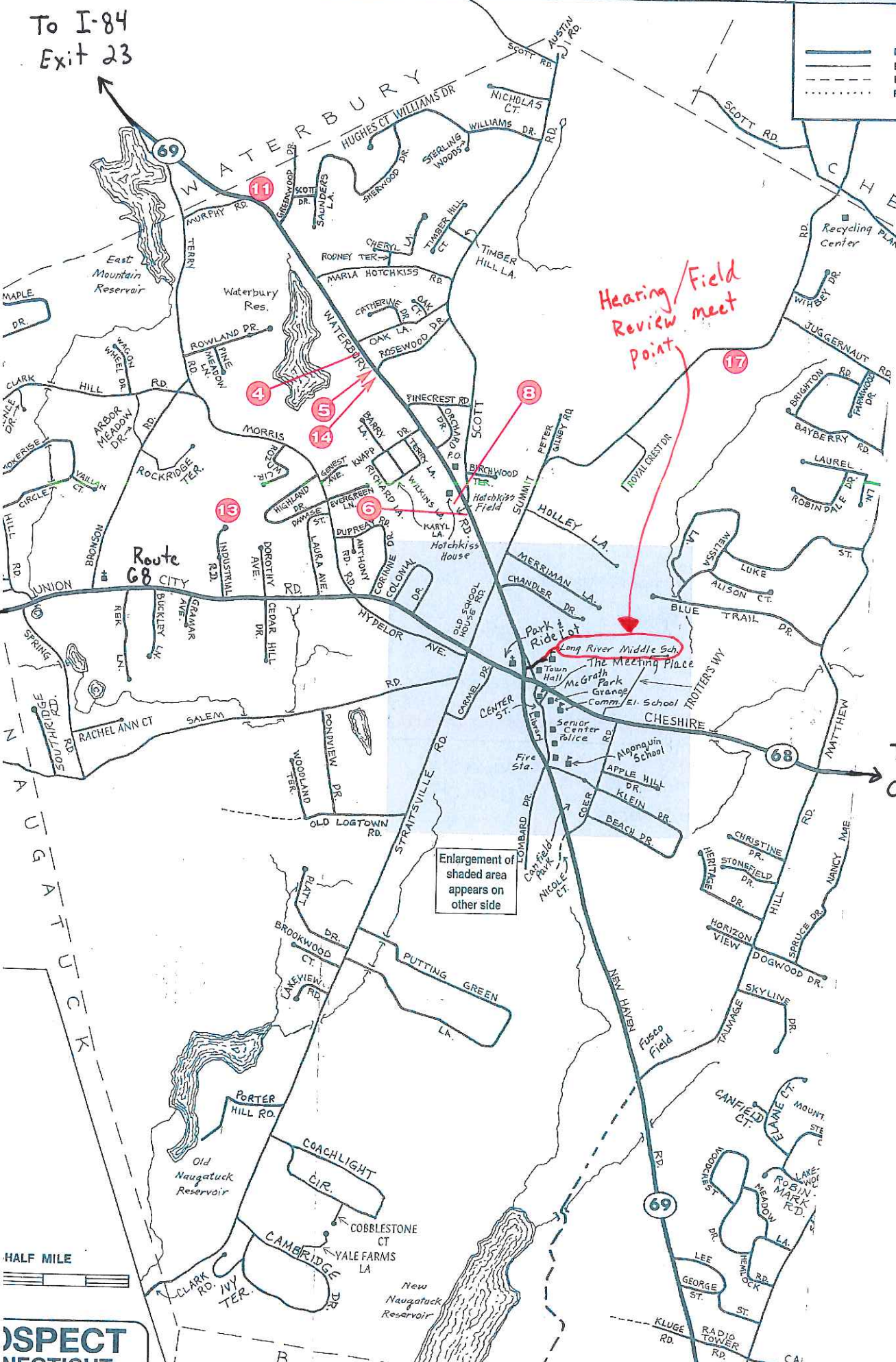
