

INTERROGATORIES TO BNE ENERGY, INC
FROM CONNECTICUT WATER COMPANY ("CT WATER")

1. Did BNE Energy, Inc. ("BNE") meet with representatives of The Connecticut Water Company ("CT Water") to discuss the potential adverse impacts to public water supply watershed lands and water associated with the construction of BNE's infrastructure?
2. Did BNE submit revised site plans that addressed CT Water's concerns regarding the potential adverse impacts to CT Water's public water supply watershed resources?
3. Is BNE willing to accept the revised plans as conditions of any approval in this proceeding?


4. Is BNE willing to accept as a condition of any approval that it notify CT Water of any modifications of the revised plans and incorporate any reasonable conditions or recommendations that would reduce or avoid adverse impacts to public water supply watershed resources?

5. Is BNE willing to accept as conditions of any approval those items listed in CT Water's letter to the Siting Council dated February 11, 2011?

6. Is BNE willing to accept as a condition of any approval that:
- a. for any maintenance activity on the two turbines involving the draining, transfer, or addition of lubricating, hydraulic or other oil or fluid having a volume greater than five (5) gallons, CT Water shall be notified a minimum of 72 hours in advance of any such maintenance being performed.
 - b. CT Water shall be allowed access to monitor all maintenance activities.
 - c. Require emergency spill control equipment be provided on site during all maintenance activities.
 - d. In the event of a spill, CT Water and the DEP shall be immediately notified.
