Dear Ms. Roberts:

I write on behalf of the Connecticut Water Company ("CT Water") to inform you that we have reviewed BNE Energy Inc.'s ("BNE") revised site plans, dated March 28, 2011, for a proposed 3.2 MW Wind Renewable Generating Project in Prospect, Connecticut. CT Water provided its comments on the proposed plans to BNE and the Connecticut Siting Council (the "Council") by letter dated March 29, 2011. We are in receipt of a letter from BNE, dated March 30, 2011, responding to our comments on the revised plans. In summary, BNE has agreed to incorporate all of CT Water's recommendations regarding the revised plans, including establishing conservation easements around four wetland areas on the project site, and to post a bond to assure the proper performance of sediment and erosion controls and other pre- and post-construction activities.

Based on the foregoing, and in anticipation that the Council will incorporate CT Water's recommendations and BNE's representations into the final Decision and Order in this proceeding if the project is approved, CT Water is satisfied that its watershed resources will be adequately protected. Accordingly, CT Water has no further role in this proceeding and will no longer participate as a party. Please consider this letter to be our notice of withdrawal from this petition for a declaratory ruling and an acknowledgment that CT Water no longer is a party in this proceeding.
